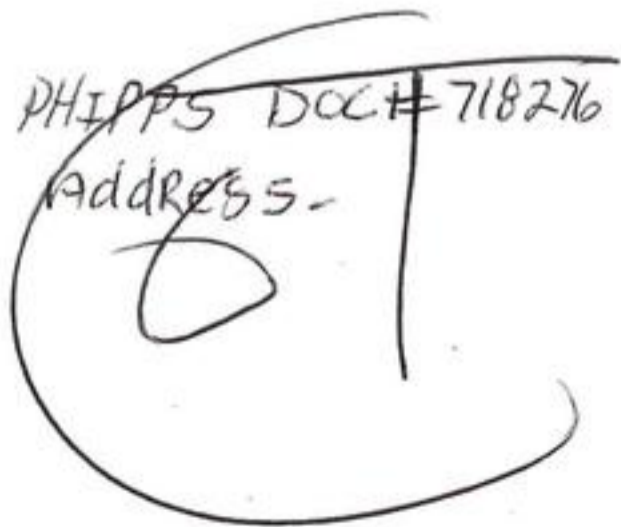
What was their response. The same as the white male Seattle police officer who murder the helpless pregnant sister in front of her kids.
