So is JAY-Z capitalized now, too? (I mean, so is this publication, so I'm not hating.)

Yes, indeed.

Roc Nation publicist Jana Fleishman confirmed with USA TODAY that "it's JAY-Z."

Review: Latest 'Transformers' reaches new bad

If Optimus Prime, Autobot leader and allaround mensch, really wanted to save humanity, he would have stopped director Michael Bay around four Transformers movies ago. The quality took a precipitous drop after the strong first live-action film in 2007, and while it's not as mind-numbingly offensive as the Revenge of the Fallen sequel, the new fifth installment Transformers: The Last Knight (* out of four; rated PG-13; in theaters nationwide now) is an exhausting marathon of complete nonsense. Even if you love alien robots punching each other while tossing out insipid one-liners, it's a painfully long two and a half hours where the biggest problem isn't a lack of plot but way too many

'Cars 3' speeds to No. 1, beating 'Wonder Woman' at the box office

LOS ANGELES — <u>Wonder Woman</u> fell to second place in its third weekend in theaters, but it's still doing the heavy lifting for the otherwise lackluster summer box office. While many worn-out franchises and franchise hopefuls continue to struggle to find a significant audience, smaller films such as the Tupac Shakur biopic All Eyez on Me and shark thriller 47 Meters Down were able to break through the clutter.

The third installment in Disney and Pixar's \$1 billion Cars franchise easily took the top

spot, but its estimated \$53.5 million in earnings told a more complicated tale.

Cars 3 had the worst opening in the animated series' history: Cars opened with \$60.1 million and Cars 2 to \$66.1 million.

It also was a disappointment compared with the top films this weekend in 2015 and 2016, comScore senior media analyst Paul Dergarabedian points out. A year ago, Finding Dory debuted with \$135.1 million. In 2015, Jurassic World raked in \$106.6 million in its second weekend.

"That kind of tells you the state of the industry," Dergarabedian says.

The G-rated Cars 3 got an A grade from audiences on CinemaScore and generally positive reviews, but it will have to contend with Despicable Me 3, which opens in two weeks.

Gal Gadot's heroic Wonder Woman was knocked down to second place with \$40.8 million, bringing its domestic total to \$274.6 million, while action/horror holdover The Mummy, starring Tom Cruise and Sofia Boutella, slid to fourth place in its second weekend with \$13.9 million.

"It's been a challenging summer. I always say it comes down to product. Are the movies grabbing people?" Dergarabedian says. "Before Wonder Woman, we were about 9% behind last summer. We're now at about even, but the industry would like to see better than even."

Amid the doldrums, lower-profile films were able to make a mark. 2Pac biopic All Eyez on Me, starring newcomer Demetrius Shipp Jr. as the slain rap star, earned \$27.1 million to take third place.

Despite largely negative reviews, <u>audiences</u> gave the film an A-minus on CinemaScore. It opened on what would have been Shakur's 46th birthday.

The Mandy Moore movie 47 Meters Down also exceeded low expectations, earning \$11.5 million for fifth. A C on CinemaScore, however, could mean it's dead in the water going forward. The raunchy R-rated comedy Rough Night also is facing some rough waters ahead with its C-plus CinemaScore. The film, about a bachelorette party weekend gone wrong, starring Scarlett Johansson and Kate McKinnon, took in a paltry \$8.1 million against a \$20 million production budget. Rough Night opened seventh, behind Johnny Depp's Pirates of the Caribbean: Dead Men Tell No Tales, which brought in \$8.5 million. The fifth Pirates film has earned \$150.1 million domestically and \$500 million internationally.

Next week, another fifth installment —

Transformers: The Last Knight — opens.

Dergarabedian expects the Michael Bay spectacle to follow suit and earn the bulk of its money abroad.

"Sometimes the bigger and better box office stories are not at No. 1," Dergarabedian says. "All Eyez on Me and 47 Meters Down are the kind of movies people are looking for. It

Weekend picks for book lovers

What should you read this weekend? USA TODAY's picks for book lovers include Anthony Horowitz's clever dual mystery, and a non-fiction account of Saddam Hussein's imprisonment.

Magpie Murders by Anthony Horowitz; Harper, 496 pp.; fiction

This is a clever meditation on the whodunit genre by one of its leading experts. Selfreferential even by crime fiction standards, it's a sharp novel about literature and publishing in the form of not one, but two entertaining by-the-numbers potboilers. Anthony Horowitz's Magpie Murders takes its title from the book within the book, the ninth and final installment in author Alan Conway's internationally best-selling Atticus Pünd mystery series, the manuscript of which accounts for half of Horowitz's novel. In the words of Conway's editor Susan Ryeland, head of fiction at Cloverleaf Books and Horowitz's narrator, "Alan had captured something of 'the golden age' of British whodunits with a country house setting, a complicated murder, a cast of suitably eccentric characters and a detective who arrived as an outsider," and he used that formula to attain enormous wealth and a broad readership.

Alan's novel shows a dying Atticus Pünd tackling one last case, investigating the suspicious death of a housekeeper and the murder of her rich employer in the quiet village of Saxby-on-Avon.

When the real world starts resembling Alan's novel, Susan finds herself in the role of detective.

Kyle Larson outlasts Chase Elliott at Michigan again

BROOKLYN, Mich. – It was a great weekend for Kyle Larson and Cars 3. Cars 3 finished No. 1 in the box office over the weekend. Larson drove the No. 42 Cars 3/Target Chevrolet to victory at Michigan International Speedway in the Monster Energy NASCAR Cup Series FireKeepers Casino 400 on Sunday.

Larson started from the pole, led 96 of the 200 laps and won a five-lap shootout to give himself a Father's Day present. Larson has won the last two races at Michigan, following up his August victory that was his first at the Cup level.

Larson also won the August 2016 race at Michigan and now has three Cup Series career wins.

He also regained the lead in the season point standings over Martin Truex Jr., who finished sixth.

Truex claimed each of the first two stages in the race.

"The 78 was by far the class of the field, I thought," Larson said. "I know I led a lot of laps. Seemed like whenever he wanted to get the lead, he hit a nitro button and would cruise up to the lead, then check out. He was the class of the field.

"I thought we were probably a third- or fourth-place car," Larson said. "To come out a winner, it makes it that much more exciting, I guess.

"I guess it would be disappointing if I finished outside the top 10 or something. For not having the dominant car, to do everything right to get a win today, was special." Kyle Busch was leading before a caution came out for debris on lap 181 for four laps. Larson went inside to pass Busch on the restart.

"Ryan Blaney gave me a heck of a push,"
Larson said. "So, I've really got to thank him
a ton. I knew the Penske cars took off good,
so I was happy to see him behind me. For us
to withstand a few restarts there with some
tough competitors there was pretty important.
I can't thank these guys enough.

"The Cars 3 Chevy was really, really fast.

And it was cool to win it. What a great

Father's Day present for myself and all the
other fathers out there. My dad is here today,
too. So, I'm looking forward to celebrating
with him.

"We've been so close to so many other wins. This is our second Cup win of the year, but we've had six second-place finishes (including the All-Star Race). All-in-all, it's a good season so far, and we'll continue to keep building on what we've got."

Chase Elliott, who Larson held off in the final stretch, driving the No. 24 Chevrolet, earned his third top-five finish in a row at Michigan and his ninth top-10 of 2017. "We had a couple of opportunities to get the lead," Elliott said. "And, unfortunately, it just didn't work out. But we'll move on. Congratulations to Kyle. He had a fast car today, and we'll try to go get 'em next week."

Joey Logano, who announced after the race that he and wife Brittany are expecting, finished third in the No. 22 Ford for Team Penske. Logano said it was good to "stop the bleeding."

"You have no idea how good this feels,"
Logano said. "It's been a struggle the last
month-and-a-half, and it's nice to come here
to Michigan, maybe our best racetrack, and
be able to overcome a lot.

"I'm not sure we had a third-place car today, but the team executed like they needed to get the Shell-Pennzoil Ford into the top three. Proud of the effort. I wish I could have the last restart back. I think I could have gotten to second. I wasn't able to stay attached to the 42. I had a good start, but the whole bottom lane was able to stack up really good and push ahead and then Denny (Hamlin) slid up in front of us; just racing there.

"Turning the momentum a bit and bringing home a solid top-five and change things." Hamlin finished fourth, and Jamie McMurray was fifth.

It was a disappointing day for Brad Keselowski. The Rochester Hills, Mich., native finished 16th.

"We just weren't really where we needed to be," Keselowski said. "We had a few bright spots, but we couldn't get it there at the end."

Timo Bernhard leads Porsche to dramatic 24 Hours of Le Mans win

LE MANS, France — Veteran German driver

Timo Bernhard led Porsche to a dramatic third straight win at the 24 Hours Le Mans race to prevent a huge upset win for the lesser category Oreca team on Sunday.

After a series of mishaps to pre-race favorites Porsche and Toyota, the LMP2 category Oreca suddenly found itself in the lead with 19-year-old Frenchman Thomas Laurent behind the wheel three hours from the end of the grueling endurance race.

But the 36-year-old Bernhard, racing in the faster and more powerful LMP1 category Porsche 919 Hybrid, overtook the Oreca with about 1 hour remaining.

As the Porsche No. 2 crossed the finish line, there were scenes of relief in the Porsche garage as team members danced around holding up T-shirts with "Hat trick 2015, 2016, 2017" written on them.

"Well done everybody," an exhausted Bernhard said over team radio. "You're the best."

Some teams were initially concerned the condensed time period would limit their ability to control the ball during the extra frame, but it appears those worries have eased, at least for now.

Although the idea of a 10-minute overtime has been a polarizing issue, the change shouldn't lead to a significant increase in tie scores. According to NFL Research, there have been 83 overtime games over the last five seasons, 22 of them lasting at least 10 minutes into overtime (the average time elapsed in overtime in the last five years is 7 minutes, 43 seconds). There have been five games that ended in a tie in those five seasons, an average of one per year. If overtime had ended after 10 minutes, there would have been 16 total ties, for an average of 3.2 times over a 512-game season. The move to shorter overtimes is just one of the changes that have been approved for the 2017 season. At the Annual League Meeting, team owners banned leaping over the line to block kicks and approved automatic ejections for egregious hits to the head. In addition, team owners approved a centralized replay to give the NFL's New York officiating command center the final say on reviewed calls.

Other changes for 2017 approved by team owners at the Spring League Meeting: 1. The NFL will no longer penalize most player celebrations. In a letter to fans, NFL Commissioner Roger Goodell wrote the league is "relaxing rules on celebrations to allow players more room to have a fun after

the make big plays." 2. There will now be only one roster cutdown deadline. Instead of cutting from 90 to 75 players, there will only be one deadline

to cut to 53-man rosters.

Two players are now allowed to return off injured reserve instead of one. Under the new rule, two players per season are eligible to return to practice if they had been on IR for at least six weeks. They can return to games eight weeks after being put on injured reserve. The move gives teams greater roster flexibility and a chance to have their best players on the field for important late-season

Horschel beats Day in playoff to win

IRVING, Texas (AP) — Billy Horschel had missed four straight cuts when he arrived at TPC Four Seasons, a course he was never particularly fond of. After winning the last AT&T Byron Nelson scheduled at the Irving resort, Horschel now wishes he could have the chance to come back. While his 18-foot birdie putt on the first playoff hole Sunday stopped just short, Horschel won with a par when Jason Day pulled his 4-foot par putt left and past the hole. "When I hit it I knew it was on a perfect line and I thought I got it to the hole. ... I just wanted to finish it off there," Horschel said. "I didn't expect him to miss it. I was expecting to go back to the tee and play the hole again."

TIGER WOODS Woods feeling no pain, wants to compete again in time

JUPITER, Fla. (AP) — Tiger Woods said he had fusion surgery on his back because he could no longer tolerate the pain, and that he wants to get back on the PGA Tour. "I haven't felt this good in years," he said Wednesday in an update on his website. Woods had the fusion surgery on April - his fourth surgery on his back dating to the spring of 2014 - and said it provided "instant nerve relief."

The surgery meant missing all the majors for the second straight year. Woods said he did everything possible to get ready for the Masters and was "ready to go." He said it was similar to the 2008 U.S. Open, which he won on a shattered left leg, because the pain was after he made contact.

"I figured, 'Can I handle it?' This time the answer was, 'probably not. That shows the effect nerve pain can have," Woods wrote. Woods had a second back surgery in September 2014, and a third one in November 2014, and then sat out for 15 months until returning last December at his Hero World Challenge in the Bahamas, where he made 24 birdies but tied for 15th in an 18-man field. He missed the cut at Torrey Pines in late January, and then flew to Dubai and withdrew after opening with a 77. That was his last round.

one part of a federal district court judge's ruling that the government claimed had blocked a 90-day review of current vetting procedures. That starts the clock on a process which could render the overall case moot in three months, if the Supreme Court has not ruled by then.

Even as the 9th Circuit panel released its 78page decision, challengers to the travel ban from Hawaii and Maryland submitted their final arguments to the Supreme Court, which could decide two things soon: whether to hear the case now or in the fall, and whether to let the ban go into effect in the meantime. The challengers' legal briefs came in response to the Justice Department, which has asked that the justices jump-start the ban now. The legal papers cited its impact on Muslims from Iran, Libya, Somalia, Sudan, Syria and Yemen — in part by reciting Trump's own words during the presidential campaign and since. They even cited the president's tweets from last week, in which he called for a tougher ban and said "extreme vetting" had begun.

But the California-based 9th Circuit court sidestepped the issue of whether the ban violates the Constitution's protection from religious discrimination. Rather, the judges said the travel ban discriminates based on travelers' nationality without improving national security.

"The order does not tie these nationals in any way to terrorist organizations within the six designated countries," the panel said. "It does not identify these nationals as contributors to active conflict or as those responsible for insecure country conditions. It does not provide any link between an individual's nationality and their propensity to commit terrorism or their inherent dangerousness." Attorney General Jeff Sessions criticized the ruling, as he has done after several other district and appeals court decisions, and vowed to push his Supreme Court appeal. "President Trump knows that the country he has been elected to lead is threatened daily by terrorists who believe in a radical ideology, and that there are active plots to infiltrate the U.S. immigration system -- just as occurred prior to 9/11," Sessions said in a statement. "The president is committed to protecting the American people and our national security." Although the Justice Department did not wait for the 9th Circuit's ruling before seeking Supreme Court intervention, the panel's objections under the Immigration and Nationality Act, rather than the First Amendment, are sure to be taken into consideration by the justices. That gives them additional reasons to strike down the travel ban, even if they do not decide that it discriminates against Muslims.

"The court now has opinions below in the full range of statutory and constitutional issues," said Micah Schwartzman, a law professor specializing in religion at the University of Virginia School of Law. "Unless the case is mooted, which remains a possibility, I would

expect the court to be F issues."

The latest appeals court ruling follows one from the Virginia-based U.S. Court of Appeals for the 4th Circuit, which said last month that revisions to the first, more stringent travel ban did not alter its religious animus. The full court, rather than a threejudge panel, ruled 10-3 that such discrimination violated constitutional protections of religion enshrined in the Establishment Clause of the First Amendment.

At issue is Trump's proposal to ban most travel from the six affected nations for 90 days, and to suspend the entire refugee program for 120 days. Justice Department lawyers made several adjustments from the first travel ban to address concerns raised by judges across the country. The revised version allowed current visa and green card holders to continue traveling, removed Iraq from the list of targeted countries and deleted a section that gave preference to Christian minorities.

Trump has said the travel ban is needed to give the government time to develop enhanced vetting procedures for people coming from terror-prone countries. Critics have said the orders amount to an unconstitutional "Muslim ban" that Trump called for during his presidential campaign. The 9th Circuit panel found that the administration had not established enough of a national security rationale "to suspend the entry of more than 180 million people on the basis of nationality. National security is not a 'talismanic incantation' that, once invoked, can support any and all exercise of executive

The court also noted that since the September 11 attacks, 12 people have carried out fatal domestic terrorist attacks - "none committed by nationals from the six designated countries."

Trump has insisted the ban is legal and has doubted his own lawyers for bowing to court rulings by issuing a "watered-down" version that still got blocked. In a series of tweets last week, he said the Justice Department should have stuck by the original travel ban and pushed for a "much tougher version." He continued a series of attacks against judges who have ruled against him, tweeting that "courts are slow and political!"

Analysis: AG Jeff Sessions defends Jeff Sessions. But what about Donald Trump? WASHINGTON — More heat than light. Five days after explosive testimony by former FBI director James Comey, Attorney General Jeff Sessions on Tuesday angrily denied any wrongdoing in his campaign contacts with Russian officials or the steps he later took at the Justice Department leading to Comey's ouster.

But Sessions refused to respond to a series of questions about President Trump's actions and motivations - including why he fired Comey, who then was leading the Russia investigation. In one provocative exchange,

Sessions refused to answer when asked if he had held high-level discussions within the administration about issuing presidential pardons to any of those involved in the burgeoning controversy.

The 2-1/2-hour hearing took an increasingly sharp and partisan tone as the afternoon wore

"You are obstructing that congressional investigation by not answering these questions," Sen. Martin Heinrich (D-N.M.) protested at one point. Sen. Ron Wyden (D-Ore.) blasted at another: "The American people have had it with stonewalling" and said Session's explanation of the reasons for Comey's firing "didn't pass the smell test." That provoked a bristling rebuke by Sessions, saying some of Comey's comments last Thursday had amounted to "secret innuendo being leaked out there about me, and I don't appreciate it."

The stand-off between the nation's highest law-enforcement official and the senators who used to be his colleagues was another extraordinary moment in an unprecedented time. At the end, what was clear was that much of this story still isn't clear - and that it isn't going to be over any time soon.

Still under investigation is whether Trump associates, among them former White House national security adviser Michael Flynn, might have colluded with Russia in electoral meddling. And still at issue is whether Trump's actions in urging Comey to curtail the Flynn investigation and then to fire Comey might amount to obstruction of justice.

The drama unfolding in the Senate hearing room continues to dominate the capital's attention and to overshadow Trump's policy agenda. Even the president reportedly watched the testimony on Air Force One as he flew to Wisconsin for an event. (Q: Any idea what the White House theme of this week is supposed to be? A: Workforce development.)

It also seems to be eroding Trump's standing with the public. On Tuesday, he set an unwelcome record for any modern president at this early point in his tenure when his disapproval rating in the Gallup Poll, based on a rolling three-day average, hit 60%. Thirty-six percent expressed approval. While George W. Bush also reached a 60% negative rating during his presidency, it was during his second term and in the midst of an unpopular war.

In Tuesday's hearing, Sessions sought to refute key accusations that have surfaced about his behavior, especially the notion that he might have cooperated with Moscow's meddling in the 2016 election.

"The suggestion that I participated in any collusion or that I was aware of any collusion with the Russian government to hurt this country, which I have served with honor for over 35 years, or to undermine the integrity of our democratic process, is an appalling and detestable lie," Sessions said in an indignant

No, that isn't snow! Coon Rapids breaks out the plows for hail accumulation COON RAPIDS, Minn. (KMSP) - The City of Coon Rapids woke up to an unusual sight Sunday morning, with snowplows clearing the streets—in June.

It wasn't snow blocking roadways this time, it was hail from severe storms that whipped through the Twin Cities area Sunday, causing damage across the state and leaving over 100,000 without power for a short period of time.

Coon Rapids resident Regina Jorde said everything in her yard was covered in hail. "It was like snow, an inch thick at least. You couldn't even see the grass. You couldn't see the driveway. It was all over the car," she said. "And I thought for sure the windows were going to start breaking."

After the storm, crews worked overtime to take care of downed trees and flooding.

And lucky for Jorde, she had a little help of her own from her great grandkids.

"I'm glad they came out because there's

really no way I could have done this," she said. Crews were able to clear the roadways by Sunday evening, and nobody was injured as a

result of poor road conditions, officials said. Weather misery for millions: Blistering heat, fierce storms and....snow!?

Another day of brutal, record-breaking heat was forecast to scorch the Midwest and East on Monday while some parts of the central U.S. were dealing with hail so heavy it looked like snow.

And to top off the weather craziness, folks in the West were shoveling real snow Monday as several inches piled up in the mountains of California and Nevada.

Fierce storms could again fire up Monday afternoon all the way from Montana to Wisconsin, and more hail, tornadoes and high winds are possible, the Storm Prediction Center (SPC) said.

On Sunday, the Minneapolis suburb of Coon Rapids broke out a snowplow and front-end loader after a hailstorm left some streets covered. Resident Ron Busch had to get out his snowblower, an unexpected development in June.

"It was like a snowstorm — of hail," he said. Thousands of residents across parts of Wisconsin and Minnesota lost power in the storm. Overall, there were more than 50 reports of hail Sunday in those two states, the SPC said. Hail was also reported in Michigan, Nebraska and Idaho.

In the far West, snow was reported Sunday and Monday in the mountains of California and Nevada, where a foot was possible in some areas by late Monday, the National Weather Service said.

But for most of the Midwest and East, heat remained the story. Many heat records were set or tied Sunday in cities such as La Crosse, Wis. (94 degrees, a record tied), Burlington, Vt. (95 degrees), and Caribou, Maine (91 degrees), the Weather Channel said. Record-breaking temperatures were likely to linger from Omaha to New York until at least Wednesday, forecasters said.

In New York, the heat may be culture shock to a city where temperatures since May 1 have averaged about two degrees below normal. Temperature records have been kept there for more than 150 years, so breaking them is no easy feat.

"Tuesday will be the worst in New York, where temperatures will reach the mid-90s and humidity will peak as well,"

AccuWeather meteorologist Evan Duffey said. "Some of the records there are ancient, but it will be close for the next few days."

Air quality alerts have been posted for the entire I-95 corridor from Washington, D.C., to Boston, because of the polluted air, which can make it difficult to breathe for very young people and those with respiratory problems such as asthma or heart disease, the National Weather Service said. The entire states of New Jersey, Connecticut and Rhode Island were under air quality alerts. By midweek, cooler air from eastern Canada will push southward across the northeastern U.S. to mark the end of the heat wave, according to Duffey

Parasite in Lincoln Memorial Reflecting Pool kills 80 ducklings

A parasite living in the iconic Lincoln Memorial Reflecting Pool has killed dozens of ducklings in the past three weeks, causing National Park Service officials to drain and clean it.

Since May 20, the NPS reports 80 ducklings have been found dead in the reflecting pool. The U.S. Geological Survey's National Wildlife Health Center "suggest" the ducks died from, "high levels of parasites that develop and grow in snails that live in the pool."

Humans also are susceptible to the parasite, warns the NPS. It may cause a noncontagious condition called "swimmer's itch," a skin rash that often doesn't require medical treatment.

The pool must now be cleaned because chemical treatments aren't enough to combat both the parasites and snails. Work will begin Sunday with the pool taking two days to drain. Crews will begin cleaning the bottom of the pool on Tuesday and all cleaning will be finished on Friday. The pool will be refilled by June 19.

The NPS said it will monitor the condition of the pool.

The rectangular pool has been the backdrop to historic events, most notably the 1963 March on Washington for Jobs and Freedom. The pool provides a reflection of the Washington Monument when looking east and a reflection of the Lincoln Memorial when looking west.

One winning Powerball ticket sold in California worth \$447M

MENIFEE, California — A sole winning Powerball ticket worth \$447.8 million and matching all six numbers was sold in Southern California and will claim the 10th largest lottery prize in U.S. history, lottery officials said Sunday.

The winning ticket was sold at Marietta Liquor & Deli, the California Lottery said in a statement. Lottery officials said the earliest the ticket could be redeemed is 8 a.m. Monday. The winner has one year to claim the prize

The store just off a highway caters to retirees who live in Sun City — part of the small city of Menifee — that was originally developed as a retirement community and motorists passing through the area about 80 miles (130 kilometers) from Los Angeles.

Liquor store owner Matthew Alberre said he does not know which of his customers won the jackpot or what his family will do with the \$1 million "retailer bonus" that lottery officials said is set aside for the retailer selling the winning ticket.

"We're so blessed for this to happen," said Alberre, who owns the store with his father. The year began terribly for the family because Alberre's father was diagnosed with pulmonary fibrosis.

"Starting out the year it seemed like it was going to be the worst year in the world and six months later our store hit the Powerball. We're very, very grateful for this to happen to our store," Alberre said.

The lucky numbers drawn Saturday night were 20-26-32-38-58, and the Powerball number was 3.

Powerball spokesman Randy Miller said the estimated jackpot prize is based on a winner choosing an annuity, which pays off over 29 years. The cash prize would be \$279.1 million. Both prize amounts would be before taxes are deducted.

Before the drawing Saturday night the jackpot was estimated at \$435 million. The jackpot had grown because no one had matched all the numbers since April 1. The odds of winning Saturday's drawing were only one in 292.2 million. Powerball is played in 44 states, Washington, D.C., Puerto Rico and the U.S. Virgin Islands.


President Trump's travel ban struck down by second appeals court

President Trump's effort to restrict travel from six predominantly Muslim countries suffered another in a string of legal setbacks Monday when a second federal appeals court said it discriminated based on nationality and lacked justification based on national security.

The U.S. Court of Appeals for the 9th Circuit based its ruling on federal immigration law rather than the Constitution's religious protections, thereby highlighting several ways the travel ban could be struck down by the Supreme Court, where it's headed next. Most other courts have ruled that the ban discriminates against Muslims.





"I don't think it's right how they treat people." here. Starting with myself! I'm protesting the way they treat inmates with mental illness. These people out here at WCI know I'm not financially taken care of, so they try to take advantage when a situation comes around because I don't have any outside help support team. I'm now on hunger strike while I'm in the hole. I had 30 stamps before I came down to the hole. They only sent me 1 stamp, saying they don't know where the other ones are....You guys have the right to use my name on the internet anywhere you can, to try and make things better. Just yesterday I told the sergeant here I wasn't feeling so good and I need to to talk to the psychology staff. they placed me in the shower area for four. hours cuffed, laughing at me, I felt ashamed and got very mad.. I used my last stamp to write to you guys. I need help more than ever dealing with the way I been treated....I have been here 10 years."

"The Wisconsin prison system is filled with black males, some o whom may deserve to be here while others are genuine victims circumstances that were created long before we ever came into this world. As someone who has spent the last 29 years under this system, my joys have all been private and my friends few. Ye my experiences have given me far more than my enemies have taken from me, and I now see things as they are rather than how they appear to be. The seats of power are filled with professions hypocrites, who are trained in the art of deception and allowed to believe that their views are infallible, and their actions beyond questions They create a favorable public image by pretending to be advocates of truth while never giving a clear, accurate, and complete account in the many reports they manufacture for publ consumption. Which brings me back to the question of how can we help each other reach a common goal. What I bring to the table is a thorough understanding of how this system operates, and I'm not afraid to challenge those who need to be challenged What I think we have in common is that: The same method they use against the prison population is also used against the public For example, when the police shoot someone in the back, and the prosecutor engages in a secret investigation aimed at depriving the public of the facts after developing the story they choose to feed the public, with a conditional confidentiality claus they hide behind... Experience teaches everyone something he/ she may not know or understand prior to the experience, and those of us who learn to rely upon our experiences are better able to deal with similar situations. It's not uncommon for inexperienced people to rely upon the views of those who claim to be operating in a professional capacity. We let doctors examir us, lawyers speak for us, and politicians think for us often because we think they are better informed. Experience has show me that any time we venture into the U.S. (in)justice system we encounter older, upper middle class white males who have devoted themselves to a political and legal system in which its' members are committed to maintaining the status quo that serve and protect their interest. But since we operate in a world where perception is more important than reality, the best way to change a reality is by first changing the perception of it. This begins with the proposition that anything they say, can and will be used against them, which will reveal for us the fact that, their concern for reputation will have a greater influence on them when the responsibility for a criminal or embarrassing act is directed to a specific person rather than an unidentified member of a group, which is often the case when one of them is caught doing wrong and blames it on the group!"

"I was notified that D.O.C. would be deducting 50% of all money that I earn through prison wages and even money given to me as a gift by family and friends. They told me that they would apply that money towards financial debts and obligations that I owe. They are collecting for debts that they are not authorized to collect such as court costs which are to be collected by the clerk of courts and supervision fees which are the sole responsibility of the department of probation and parole. The courts have sent notification in the form of a judgment of conviction telling D.O.C. which debts to collect and to collect for them at a rate of 25%. However, the D.O.C. has incorporated a rule that the claim supersedes the judgment of the courts. This rule allows them collection from all moneys at a rate of 50% for debts as well as an additional 10% to be put into a release account. This leaves roughly 40 cents out of every dollar to be used by me. The D.O.C. is applying this rule to the majority of persons who are incarcerated and it began not even 6 months ago."

"DOC policy for chronic pain is reflective of the social problems of today's abuse of pain relievers. One of the things that is different from the problems that plague the streets is that in here we are in a controlled environment making abuse of anything other than muscle rubinonexistent. During my stay at Oakhill they went through five doctors in my nineteen months stay there, currently they have no doctor; the nurse practitioner has no authority to sign the prescriptions. In my case a committee in Madison who knows nothing about me and never examined me assessed my medical needs as no longer needing pain medication. Because I still keep pursuing them I have been sent to two different pain clinics eight different times. This last time the MD needed the DOC policy on narcotic pain relievers. Two weeks have passed and they still have to address the recommendations of the doctor there. For people like me with different spinal breaks, pain killers will be a necessary part of my life for the rest of my life." -- Anonymous

I'm sentenced to life plus 45 years, and chance of parole in the year <u>"2104"</u>. Now after I saved 500 dollars in my release account which I can't touch, now for some odd reason, now I got to save 5,000 dollars for when I return to society. Now according to the Memorandum dated Sept. 25, 2009 read as Follows: "Although the rule became effective on Sept. 11, 2009, computer programing changes to allow for this rule are not complete. Until this can be done, current processes in regards to the \$500.00 and the 15% will continue. Once the programing updates are complete, accounts will be reviewed, on an individual basis, to determine if adjustments need to be made." Now if one looks at this statement, and I am not an attorney, but look at the word they used. It didn't state it's the law but they use the word rule. Now even though some might say, "Oh! That's what they mean by rule it's the law." Well let's go another step into this matter. They did say: "Accounts will be reviewed, on an individual basis, to determine if adjustments need to be made." No; the argument is this: "I am never getting out, my first chance of parole is the year "2104". People it's only 2017, I've been incarcerated since 1993. Do it seem like that I'm getting out soon? Now I can understand if I had twenty or thirty years to do, then of course. But see these so-called rules, brings much stress to us lifers who not getting out. Anybody with common sense would see that this isn't right at all. Now to go on with this craziness here at Columbia. The warden here has been moved around from Waupun Correctional to Red Granite to here at Columbia. This warden has taken horse shoes away from us. He had us on lock-down (oops) until about one month and a half while he (the warden) was in Canada on vacation. Many of the regular guards either quit or found better jobs because the warden is forcing the guards to work overtime. At times the guards (the good guards) will help us out at times. But the old staff will get on the good staff by saying: "Don't do that! He's an inmate.". It's like a double standard here."

"Deliberate indifference to serious mental health needs. CI02 Wadack Meuller and Psychology staff refused me any form of treatment before or after suicidal lapse. I told CIOs, I was suicidal 5 times and even told them my plan and they refused me treatment. So I cut my left arm open deep and passed out and second shift did emergency cell entry because first shift left me to die for one hour and thirty minutes. 'Pscyh' staff names are T. Vanburen and J. Engstrom—they are all at the Waupun Correctional Institution, P. O. Box 351, Waupun, WI, 53963. I'm going to wait to submit my other paperwork until I get to my next placement because of sabotage because of me suing them for 3 quarters of a million. I'm exhausting my remedies as we speak and yes, 'I'm very afraid of sabotage' but not 'afraid to give up on self and others,' who 'fights the fights for prison rights.' So by March I will be in court on 'Deliberate Indifference.' If anyone can help me with litigation I would gladly appreciate it because I'm a little shallow of the law. But I know one thing, 'I'm fighting to the end!' I also give IWOC my permission to put my real name and DOC # in any paper work for newsletters and whoever else wants to help me with prison rights. Plus help me get educated about law and whatever else else needs to be none." Adrian L. White, Waupun Correctional Institution,

"I want the outside world to know on how the inmates are being treated by the officers that work here at Columbia Correctional Institution. They have little to no respect for the inmates. The officers talk to us however they want and when an inmate says something we are the ones that get wrote up and punished. They make all these rules for us to go by, that we can't do, but the same rules they break right in front of us inmates. How can an inmate rehabilitate him or herself when these officers have so much hate and always refuses to give or provide treatment for us inmates and how even the decent officers quit or left the Columbia Correctional Institution to go work elsewhere because of how things are being run around."

"My issue with WCI is a denial of health care and not keeping me safe. I suffer from a rare genetic connective tissue disorder called Ehlers Danlos Syndrome Type 3, Hypermobility. This causes my joints, muscles, and organs to come apart and is very painful. I can barely function anymore because my pain is so intense and my physical health is so bad getting dressed, making my bed or walking around is exhausting and showers often cause me to collapse. WCI is refusing to do anything that gives me any real relief, or slow the deterioration of my body. Their reason for not giving me the proper care for my illness is 'If we gave you that we would have to do it for others."

"I've been here at Columbia Correctional Institution for twenty-five years. And this is my first incarceration in prison. I've seen many things here at this prison and not for the good. Why is it that the 'state' law states: There's to be no smoking at all or any kind of tobacco products on state property. And that includes the state parking lot. But it seems that the rules are not taken seriously by state employees. I wonder why? The new warden here tends to make everything gang related. Why is it that guard can talk to you any kind of way and get away with it? Are these new rookie guards being primed this way or is there an agenda behind this mass of disrespect towards inmates? What's really going on?"

"Waupun Correctional Institution (WCI) houses seriously mentally ill prisoners who are dangerous to themselves and suffer from various forms of serious mental illness. Including major depression, schizophrenia, bipolar illness, schizoaffective disorder, various personality disorders with significant functional impairment, post-traumatic stress disorder, severe developmental or other mental disabilities and other chronic and serious mental conditions. Prisoners with serious mental illnesses are sometimes confined in the Restrictive Housing Unit (RHU) for months or years without adequate mental health treatment, with predictably devastating results. These conditions exacerbate their mental illness, making them increasingly dangerous to themselves and others. Their inadequately treated illnesses often lead to aggressive and violent behavior which is in turn used by the staff as justification (if not pretext) for further acts of extreme isolation and violence directed at the prisoner, thereby establishing a vicious cycle in which anger begets a violent response that begets more anger. Many of the prisoners housed in the RHU suffer from serious. chronic mental illness. Some of them have been housed in the RHU for years. Some routinely smear themselves and their cells with their own feces. Some howl or shriek continuously. Staff who are responsible for the care of these prisoners intermittently torment them by yelling at them and antagonizing them as if they were reviled animals. Many of the seriously mentally ill prisoners at WCI do not and cannot hide their conditions. They scream, howl, mutilate themselves, smear their waste and beg for help. Many have long, documented histories of serious mental illness. Many have requested for mental health intervention, to little or no avail. I will never come off this hunger strike until I expose the corruption and inadequate mental health treatment at Waupun to the government and the world. Therefore, we are asking that you join us in protest and fight to right this and other egregious wrongs."

"I've been doing this eleven and a half years now and I can't count on one person out there to do anything more than lip service when it comes to putting the spotlight on the problems with the Criminal Justice system let alone the DOC. I stand with San Francisco 49ers Quarterback Colin Kaepernick in sitting down during the so called 'National Anthem.' I do not pledge allegiance to a piece of cloth. That cloth which represents the United ** Hypocritical States of America. Where separation between church and state is a talking point, because there is no separation. Liberty for the rich and justice against all poor and oppressed people. I've been representing myself 'Pro Se' in court for the past six and a half years presenting evidence of my innocence from the trial court all the way to the 'Seventh Circuit' federal appeals court, back down to the state court of appeals for the fourth time. I'm currently awaiting on a decision on my petition for Habeas Corpus review. And just as I am alone in this cell writing this letter, I'm alone in this fight. Let's look at where the injustice is: the policy makers, law enforcement leadership who target people, the propaganda surrounding the need for bogus policies, then move up from arrest, conviction, appeals, and then the conditions of confinement. Now I have absolutely no problem donating my time, knowledge, writing abilities, and my voice to a righteous cause. At the very same time I must insist on a quid-pro-quo arrangement in the name of justice."

"The situation here in GBCI is rapidly descending from madness to something akin to Soviet style policing. The entire administration starting with the warden on down hasn't been here for more than a few months and already they have systematically changed everything that has been in place for the last 30 years. Restricting the already limited movement down here to police escort only and making it next to impossible for us to receive legal assistance from other inmates who are proficient in a wide range of legal matters. These people are begging, literally begging for a violent uprising. I'm not talking about nowindows getting broke; and guys refusing to lock in. No. It's full scale outright war against anybody not wearing green and can't walk out these doors at will."

"There's been a great deal of injustice and cover-up at play as usual within this corrupt system. It's only unfortunate that there's little to no grassroots movements and the mental illness is rampant in these modern day plantations. There have been multiple questionable death at Green Bay with 2 suicides back-to-back from individuals who unquestionably had mental illness and and I were told had requested psyche service to no avail. Then there was the situation with Frankie who for reasons found it necessary to attack staff and days later dead. Of course it was claimed to have been a suicide-the question how one can kill them-self in observation with no clothes only a smock and hard rubber mat to sleep on? Then some 17 days later Wilfredo threw hot water on a guard named McKace who had a history of issuing petty conduct reports, harassing prisoners in the kitchen and firing them for eating an extra cookie or a piece of cake never mind you're working fo slave wages. A 1-rate less than \$10.00 every 2-week dish washing, 2rate pots and pan 2-rate sanitation or 1-rate cutting grass, shoveling snow in the winter. It's crazy! So yes, we were placed on lockdown even though the situation was isolated. But then, it was an opportunity to politically posture as the overworked unprofessional guards lamente they felt unsafe. But these are the same corrupt, rogue guards that tak every opportunity to screw over prisoners. At times I feel like the last o a dying breed where struggle and prisoner consciousness are concerned. The warden, deputy warden and security director are creating an environment of guards vs. prisoners and administrators vs. guards which keeps a climate of hostility. Many of us who have been abused and cry out are labeled trouble makers, liars and there is the attempt to create a perception we deserve the mistreatment. They are now attempting to deny recreation to those prisoners who work or attend school. When these so called suicide cases come forth they need to be investigated independently to see more beyond the smoke & mirror."

Voices From Columbia Correctional Institution:

"I once read a beautiful article on Hurricane Rubin Carter. In it Hurricane talked about the story of a magician that put labels & spells on the animal kingdom so that they will view each other as prey and predator, while the magician was creator or godlike. The story, I took as an analogy on how politicians and other elitists keep the working class and the have-nots fighting against each other while they rule."

"The one thing that a prisoner & the guard both have in common, yet most don't want to acknowledge—is they are both relatively poor & powerless in the scheme of things... They are slowly but surely phasing in these food rationing measures. Every week the food is short or missing altogether... How is it productive to treat me like an animal—when laws protect them (the animals) better—and downgrade my humanity. The prison class is the most excluded and disenfranchised class. But we are a factor."



A Voice From Stanley Correctional Institution


"I wanted to get my reading scores up, somehow, they have my score below 10.0 (which is wrong). They love to lose your scores in the system, which is what they told me. Well, I also know "you can find it, in the very same system they lost it in."...I also had my lawyer on it, who made a few calls for me. But since the complaint, they literally have posted for me to come test (which I refused now). I'll wait until I go somewhere else, and also, I wanted to prove my point (on paper) on how they try to hold us back from educating ourselves. In my case, I was only trying to raise my reading score up. Last week, they pulled up the piping in the kitchen, one hour before lunch is to be served. They completed the kitchen on our unit, and went to the next unit. But for days, dirt and dust was in the same area they served our food at. Some guys just didn't eat for days. And you would think the they ask the custodians to come clean up the area (Right?) Well, no, because I work as a custodian on the unit and they made it clear that they didn't want us in the area to clean up NOTHING! I know for a fa this was a safety violation, had our food being disher out as dust particles flew in the air and dirt trails all it the hallway. We had to eat like this for about one week, until they finished the piping. These people, keep doing fund raisers for the puppies (Stanley has a dog program where they train dogs for disabled people). Which I support. But hell, I hate to say it but 'dogs are being treated better than inmate's here."
