Monday August 28, 2017, I sure seem to tick staff off over here at Union Correctional Institution (UCI) its a real mess over here, nothings changed. Okay - I'll give you this, staff aren't assaulting inmates, but they are trying to have other inmates assault inmates that they have problems with. which is exactly why we need body cameras on these officers. Cause thats the only way we're going to stop this abuse corruption... hey lets call it what it is, Criminal Conduct."

yes I've got a yard sgt, and the Admin sgt here in P-Dorm death row housing trying to encourage inmates to jump on me. This yard sgt. takes the inmates extra mattress on August 16, 2017 and says we're taking it because Ronald Clark snitched on you. The inmate informed me. I said "Bro I didn't even know you had two mattresses." He said, "I know, and I see what their trying to do, their trying to get someone to jump on you."

Today I sent a 5 page letter to Assistant Regional Director MR. John Palmer, informing him of this and so much more. we've got to weed out the low life unethical Criminal Correctional Officers that do stuff like this. We need body cameras on these officers, cause that and mandatory lie detector test is the only way of exposing the criminal element that works here.

I can say this, at F.S.P. From May 4, 2015 till March 2017, them officers "toed the line with professionalism". Cause Mr. Palmer put the "FEAR OF GOD" in them officers. I like warden Jordan, but he's not MR. Palmer. I'm about to open a can of worms, some of you tax payers should like it. For instance Sunday August 13, 2017 this Administrative sgt's sleeping over time. Thats right not working, he's getting paid to sleep. your tax dollars, He has it so good here, he's got inmates that buy's his lunches and

I was trying to expose this two and a half years ago, when he was the yard sgt, sleeping on the yard and charging inmates for extra yards, yes a soda sandwich and bag of chips would get you an extra yard. He would fill his belly and sleep. Where was the security? That's a good question. Answer security was in la la land dream world.

When going to medical earlier, the yard sgt said why aren't you going to yard with a smirk on his face. see Thursday August 24, 2017 at approx 3:20 PM. they moved me from cell P-4127 on the south end, to 3103 on the north end. Now they say it was because the cell was messed up, cracks in the back wall. However this cell 3103 is in worse shape than 4127. Besides why move me all the way to the other end of the building, when all they had to do was move me right down the hall 4117 was open, there was cells open on both sides of 5-wing and 6116 was open. And when that Admin sgt was moving me, I said "you know I got problems with some guys on the north end." He ignored me. Know why? Cause their trying to set me up. And they very well may have it set up on this wing to make it happen. Only problem I have is, what do they have set up? simple assault? or more?!" I just don't know. How many people would I be fighting? Cause there's at least 4 that I'm sure of whose over here, who would take these sqts up on something like this.

All of this is de jara, it has gotten started over a simple letter that I wrote to the assistant warden trying to get three two hour rec's rather than two

three hour recs. Cause if we lose one rec, that's 50% gone. at least this other way it would be 33%. But like I said, "this place is resistant to change!" And if the law makers or rule makers ever get this work out to where we are given plenty of out of cell time, then the inmates will no longer have to buy recreation, which we shouldn't have had to do.

I'm sitting here smoldering over this misconduct and reckless behavior, and I'm chomping at the bit, thinking about going to the senator, cause this behavior is unexcusable, "you do not pit inmates against one another!"

I do pray for these officers, even when they make me angry, but sometimes action is required. Christ prayed, but he had to react, in order to fulfill. And if these officers are doing this to me, they'll do it to others. Change is needed and the only way to bring change is to expose the abuse. may God bless you and remember the Golden Rule. Matthew 7:12, "Do to others as you would have them do unto you."
