As noted in the previous responses, there are security risks that may be presented when an offender wears

As noted in the previous responses, there are security risks that may be presented when an offender wears coveralls to the shower. This includes unauthorized items being hidden in the coveralls. Washington State Penitentiary (WSP) Administration have directed custody staff that work in restricted housing there to escort offenders to the shower in boxers and t-shirts. This is the stance they have directed and as a result all offenders going to the shower will be required to wear boxers and a t-shirt. Staff have been reminded of this requirement. There is no supporting information available to support your claim that staff are singling you out. Additionally, I contacted the Headquarters PREA unit and this process does not violate PREA standards.

In the upcoming months restricted housing staff across the state will be discussing processes and procedures that can be standardized and made consistent across the state within all restricted housing units. This issue will be discussed further at that time.
