## The nasty Default

My lawyer was Public Defender Billy Grantham said under oath I do solemnly swear to (or affirm) that I will conduct myself as an attorney or counselor of this court, truly and honestly, justly and uprightly and according to law; and that I will support the Constitution of the State of Georgia and the Constitution of the United States. So help me God. He took this oath in vain, let me tell you why. Every day I had to call Mr. Billy Grantham or go by his office to see him about did he hear anything on my appeal. Very nasty default. All of certain August 13, 1998. My ~~last~~

Foster parent Liz came by the hotel where I was living and working. She said Jennifer you didn't know you was suppose to be in court August 12, 1998. I said no but I was just in Mr. Grantham office ~~again~~ asking about did he hear anything on the appeal. Mr. Grantham said no he hadn't heard nothing. My foster mom had to turn me in because she was my bail bond personal. I end up with a bench warrant in my file ~~do~~ as if I had jump bail. Mind you I couldn't understand why unmarked cars, people on feet was following me. Also vehicle with camera was following me. I remember coming out of my hotel room. Getting into the car with my cousin-in law Rhonda to go to my second job Cargill. When I seen a white guy that was ~~chased~~ dressed in casual clothes across street walking and watching me. You would thought I was drug dealer wanted by secret indictment unit. Clearly I never sold a drug in my life. I didn't understand what was going on. Once I got my transcript. I learned the Supreme Court had ruled on my case July 06, 1998. Mr. Grantham filed reconsideration July 31, 1998 which was denied. Remember Mr. Grantham kept telling me he hadn't heard nothing. Being low down in the know because what I am African American that is in poverty, which leads me to believe what other traps they set in this case. Because I am looked at as shy, scared and want stand for myself. Clearly this was a nasty default. The whole state representative was checked it. Even if they thought I was going to run back to New Jersey because that where I had previously move from. Why would I run when I know I had not done nothing wrong.

Just because someone has an accusation against you don't make them true. Just because someone drag you in the courts of law don't make it true either. You see how easy it is to over exaggerate situations. Make it seem so true. Mr. Grantham did get away with this nasty default. Currently I have appeal pending in the Supreme Court. So I filed a Supersedeas Bond in DeKalb County Superior Courts. Judge J. Kevin Chason said the following: It appears from the records in the office of the clerk of this court that the Defendant was convicted of felony murder on August 17, 1997 under O.C.G.A 17-6-14(g) No appeal bond shall be granted to any person who has been convicted of murder. Very bias and prejudiced personally. Therefore Defendants motion for supersedeas bond is hereby denied. Myself and legal ~~assistant~~ de clerk look this O.C.G.A code up. It does not exist. Another nasty default by this judge. Clearly you are bias and prejudice against my case. According to O.C.G.A 5-6-46, 5-6-37 and 5-6-38, 17-6-15. I am eligible for a supersedeas bond because right after my trial. I got out on a supersedeas bond. I was found guilty of murder. The reason he denied my motion is not because a convicted murder shall not be granted a bond. It because I am inmate he feels I know too much. So he playing me as if I don't know what I am talking about. He ain't going to acknowledge me inmate. Just because I am inmate. Your not going to treat me as if I don't ~~as~~ have no rights. You see the nasty default in this it took them two days convict me off of hearsay evidence. Which is not permissible in the State of Georgia. Which these two days ruin my life. But it's taken more for people to admit their wrong because

their pride is swelling. Nasty defaults happens all the time. It caused people their livelihood and destroy their family or families while these people continue to reign in authority. Which that is not right. When a judge or president of the United States cannot admit they are wrong that is sad. The saddest thing they have all these ~~money~~ lives in the palm of their hand. If they don't get what they deserve on earth which is judgment for taken advantage of the disadvantage people. ~~Judge~~ Judgment Day is coming with the Lord. I hate to say these leaders is going to lift their eyes up in hell. because of the way they have shed innocent blood. For the one don't believe it's a hell. A lot of these leaders set in these churches. such as my lawyer he had a church home. But the Lord was not in him when he was dealing with people and cases during the week Monday - Friday he was bring destruction to people ~~lives~~. That was helpless. Who are the helpless people: homeless, children, disable, senior citizen, ~~poor~~ people in poverty, immigrants, mental health, single women, college students, veterans, ~~widows~~ widows, ~~single~~. Instead of our judges, District attorney and President helping others. With our judges and District attorney they are so hungry to put people away so quickly. They have getting from honest justice to judging. The same way with Donald Trump he is personally judging these immigrants. Before it's over with. I am going to say this. The very thing you try to teach somebody else make sure that lesson is not for you. When you try to make

Somebody else suffer. you end suffering even worse. I had a family member who was taking care of me in my helpless estate they stop because they wanted to teach me a lesson because they felt I was spending too much money. I was hard headed wouldn't listen. They handled me like I was child. They began to belittle me, and tried to make me feel unworthy. ~~The~~ This individual had won a lot of lawsuit. So they had money. Now they have nothing. So now they asking other people in the family for money. and I ~~rejoicing~~ rejoicing because of their misfortunate. ~~Absolutely~~ Absolutely not but you reap what you sow. whatever you put into the universe that what you will get back. The ~~person~~ person vowed to help me till I get out of my helpless estate. Donald Trump and Judge Kevin Chason took oath to do right by the people. Quick testimony - when my mishap was going on. My landlord evicted me in one day because of the false allegation that was against me. He was nasty to me.
