**I WANT TO GRIEVE:** Today was the end of <sup>subject</sup> CO J. Kelly, Leonetti, M. Watson, several other 2nd shift floor staff discriminatory, an ~~authorize~~ psychological experiment over the food tray for which these CO(S) subject me to. About 90 days ago CO Leonetti, Watson, J. Kelly, K. Kelly, etc Demand that I remove the pre package card board food tray out of the plastic trash bag that I discard at lunch every day. Their reasoning because it make it easier for them to pick the food trays up or take them from my hands. Saying no need to comply. They begin to contaminate my food tray with some kind of substance they called hot sauce. It cause a burning sensation and perform taste in my mouth. On 9-1-18 CO J. Kelly and Smith-Seth was blocking the visual of the cup-port as to present me from observing how other offenders hand out the food trays. upset that I handed out the food trays the same way with the lid at the bottom. CO J. Kelly, Smith-Seth throw food on the cup-port in and out side of the cell. Then they the cup-port door extremely hard in loud. Today CO J. Kelly Demand that I remove the card board food tray from the bottom of the stack of food tray and place it on the top. When I didn't comply he threaten to stab me in the side and did not pick up the lunch food tray. I try to get him to take the food trays but he wouldn't.
