Q57: Upon what factors do selecting a marriage partner and guaranteeing a marriage's continuation uniformly depend?

A57: There should be some parity of intellect and sanity. Communication is the root of marital success, so partners who have the same communication level will get along best.

Q58: How is communication lag an important test for marriage partners?

A58: Where one partner is fast and one is slow, the situation will become unbearable to the fast partner and miserable to the slow one.

Q59: How do cut communication lines affect a marriage?

A59: Cut communication produces uncertainty. Sensing trouble partners react strenuously - feeling entitled to open communication.

Q60: Give an example of how you could help someone repair their marriage.

A60: A Third Party must be present and unknown in every quarrel for a conflict to exist. Discover this third party factor and resolve Misunderstands in order to re-establish primary partnership agreements for optimum A-R-C.

Q61: Why must one raise a child so that he is in full possession of himself at all times?

A61: You want to raise your child in such a way that you don't have to "control" him. A child has an inherent right to his self-determinism*. As they live - they learn. Freedom for the child means freedom for you.

Q62: What can a parent do to ensure that a child retains his self-determinism?

A62: Give the child leeway to learn by experience and maintain communication to develop reality checks.

Q63: Why must anything given a child remain under his exclusive control?

A63: It's not still yours if it's been given to the child. Children learn responsibility with whatever it is under their exclusive control. Abandoning the possessions of the child to their fate means eventual safety for the child's possessions.

Q64: Give an example of how you would handle a child with regard to his possessions.

A64: With reasoning, communicate the reality of responsibility (of control of space, energy and objects) and encourage a self-determined origination of an ideal scene, as a demonstration of understanding, in order to establish optimal A-R-C.

Q65: Why must a parent permit his child to contribute?

A65: A family is a group with the common goal of group survival and advancement. A child not allowed to contribute or failing to understand the goals and working principles of family life, is cast adrift from the family. He is shown he is not part of the family because he can't contribute. So he becomes anti-family - the first step on the road of being anti-social. A human being feels able and competent only so long as he is permitted to contribute as much or more than he has contributed to him.

Q66: Give an example of how you could permit a child to contribute.

A66: Simply accept their self-determined effort in the spirit it is given. Validate their "help". Smile at their entertaining antics. As they mature and understand common goals of group survival, they'll display greater responsibility in their contributions.

Q67: Why is it important to explain to a child the working principles of a family?

A67: Once they're mature enough to understand the family dynamic goals and responsibilities - Reality is developed... by Communication. Understanding permits greater Affinity and corresponding Freedom. A child's Security relies upon Understanding.

Q68: How could you explain the working principles of the family to a child?

A68: Food and rent are earned with labor. Education permits better earnings. Better earnings produce better toys. Toys last as long as they're cared for.

Q69: What happens when a person can experience exactly what has been done to him?

A69: Confronting the ises of life enriches A-R-C. Happiness is Interest. Happiness is the overcoming of not unknowable obstacles toward a known goal.

Q70: Why does happiness depend only on the ability to confront reality?

A70: Maintaining communication with what is, is the very definition of SANITY. Being able to confront reality permits greater understanding and corresponding freedom.

Q71: How can a person's life be affected by his actions that others cannot experience?

A71: By adding confusion, one fails to demonstrate optimum A-R-C. This prompts a dwindling spiral as "bad cause" is considered - and this may result in impeding efforts to be cause.

Q72: Do you agree that adherence to the two golden rules would lead to happy living? Explain.

A72: No, I don't agree. Progress is made by challenging status quo. The agonist prevails through the ordeal. Happiness is not itself an emotion. It's a word which states a condition - and the anatomy of that condition is interest. Happiness, you could say, is the overcoming of not unknowable obstacles toward a known goal. Raising the bar of Awareness and corresponding Responsibility disturbs Wog's* that will never be equated "bad cause" by me! Permitting mediocrity in a mediocre world is counter survival to Homo sapiens*!
