I am addressing a serious matter here at the Avery-Mitchell Correctional Institute^{#4680} where it is plain and clear that certain staff members here are discriminating against Trans-genders, and deliberately placing them in harms way.

This camp is designated as a hub of some-sort to accommodate Trans-genders whom are taking medicine to aide in their transition; also they are given the chance to receive clothing in accordance to their gender identity.

I am personally associated with one Transgender person; and she was under my watch since September 2018; that is I've been somewhat like a guardian so to keep bounds off of her and to keep her from being preyed upon by hostiles.

Well about a week or two ago on 1/1/2019 a Sgt. see note, decided he was gonna move this person to another block - to split us up per se; I offered to move myself because in this block she was safe and stable, she knew people and would be ok; and I'm gonna be ok where-ever I go!

This Sgt. and his staff said no, and moved the 24 yr old Transgender instead; and in less than a week (3) people approached this kid inappropriately, to seek sexual favors! While with me in this block & she never faced such uncanny solicitations!
