THERES SO MUCH ABOUT LIFE THAT IVE MISSED. IVE NEVER BEEN MARRIED, NO CHILDREN, NO DRIVERS LICENSE. IVE NEVER EVEN HAD A DRIVING TICKET CRAZY HUH? I HAVEN'T HAD SEX IN 25+ YEARS NOW THATS FUCKING CRUEL YA KNOW. IVE ONLY USED 1 CELL PHONE IN MY LIFE BACK A FEW YEARS AGO WHEN I WAS IN A PRISON CALLED CMF, CA, MEDICAL FACILITY IN UACAVILLE CA.

EVERYBODY ON THE STREETS TAKES LIFE, FREEDOM FOR GRANTED. IVE LITERALLY FORGOT HOW LIFE IS ON THE STREETS. ITS VERY SAD YEA BUT IM NOT GOING TO DWELL ON THE PAST. NOTHING GOOD CAN COME FROM IT SO I CHOOSE TO NOT DO IT. I WAS DEACT A BAD HAND BACK IN 1994 BUT IM ALIVE I MADE IT THIS FAR. MOST COULDN'T DO 25 YEARS IN PRISON.

IM GOING TO END THIS POST BY SAYING HOPEFULLY SOON SOMETIME THIS SUMMER MY ATTORNEY WILL SEND ME LETTER SAYING MY COURT DATE. WHEN I GET MY DAY IN COURT I SHALL GET MY FREEDOM BACK.
