If they move us, plans change here all the time, the plan they had ten minutes ago may change, but if they stay on course, then I've got to clean a cell, then try to put my legal work back together. And its going to be a sweat box in here today, so its going to be rough!:-(

8:47 am, they called master count. Some type of drill. I was all the way down in the law library, when they called it. So they had to bring me back. Now waiting for it to clear, so I can go back to the law library.

Went back to the law library around 11:00 am only stayed about 30 minutes. They were running behind. And because of all of this, they didn't move us. So we've got to pack up again on Tuesday. I'm really tired. I got up too early. Yesterday they worked on the TV antennas and messed them up even worse than they were. Its a bit hot in here, but at least the humidity isn't real high. My hip is hurting. I was hoping to see that doctor today. But it didn't happen. I kind of figured it wouldn't after seeing that ARNP Collins last Monday. This medical company is trying to make money, not spend it. You get tired of this place, it wears you down. You get tired of all the drama. These inmates are ... Ever hear if you don't have anything good to say, then don't say anything at all. Oh well!

6:28 pm, They just started the showers. It'll be another 20-30 minutes before I get down there. Only two showers. Its been along day, been along week.

Back from the shower. I'm really tired and ready for bed. Wish they would have got these cell moves out of the way. I'm going to lay down, my alarm will wake me up for master count at 9:30.

Got up at 4:00 am, still hurting. Doctor Toledo didn't see me yesterday as he said he would. Its probably going to continue to be a battle as everything is. It really wears you down. Which I believe is their intention. They've got coffee cake for breakfast which I don't eat. I'll have some oatmeal. Its been a really long day. I had a beef stew from the canteen for lunch. For dinner ,a ramen noodle soup with some fish in it. Food here is really bad, the product is bad, and the cooks, if you can call them that ,are sorry! None of them have pride in what they put out. All their focused on is what they can steal and sell, so they can earn money for canteen. So if you steal the good burger patties, you make some cheese burgers you take them back to your dorm, and you've got an item that you can trade for coffee, chips ,cookies, cakes ect ect. Inmates here don't get paid ,so they've got to do something. One way or the other, the FDOC is paying for those inmates services. Twenty first century slave plantation! Call it like it is.

Well its been brutally hot, I'm going to wash up and call it a day.

Another hot one today. Feel like temperatures in the 100's.On the street its not that bad, but cooped up in this cage, "sweat box", with no air conditioning, its dreadful! I watched the Indy 500 today. I'm in so much pain from this hip and knee. I've got to get something done. I can't keep living like this. I'm miserable!! And its almost 7 00 pm, and its still really hot in here. I'd like to have an ice age. This heat back here is so hard to deal with. I'm about to lay down and call it a day. Put this little fan up by my head to blow on me.

"DAILY JOURNAL" MONDAY MAY 27, 2019

Its been like an oven in here all day. This is just miserable! They got these fluorescent lights on, which have no covers, which should be a security issue. Its glass that has no safety cover on it. They always talk about security, that's a serious security issue.

Tomorrow its suppose to be even hotter. This is the time of year I struggle. If we had air conditioning back here, I'd be alright. But we don't, and this heat is really bad!! You don't know, until you step through that front door. Where the officer's are out there, its nice and cool. Its brutal back here were we are at. Would have been a nice day to be at the beach, or be riding a motorcycle.

Its been along day, I'm ready to get my shower, and lay down. See what tomorrow holds, today has been boring. No rec or anything due to the holiday. And all three meals have been nasty. Tomorrow we have chicken, which is the only real meat we get. Everything else is processed. We're also having a really bad ant problem. There's ants all out in the hall, and some guys have them in their cells. Its a wrap, another day on the row.

Its still hot in here. This morning when the officer was serving breakfast, he said"Damn its 5:00am and still hasn't cooled down. Well it has, he can't tell because he's out there in the air conditioning, and then has to leave that for this misery. We've been told we've got cell inspection this morning, but we were also just told to pack up, that we are being moved this morning. All I've got to do is fold my bed up. Its already made, and I'm not taking it apart until they come to move us. Once we move, I'll be cleaning the cell for at least 45 minutes or so. When they put us over there Thursday during that shake down, the sinks toilets and floors looked pretty bad.

5 top, and 4 wing are going to rec. Just sitting here waiting on the cell inspection or the move. Its friggin HOT!!! "" I do not do well in this heat! I'm good with it freezing cold! You can always put on clothes to get warm. You can strip all the way down, and still be miserably hot! And I'm dressed in class A waiting on this cell inspection.

9:25 am, I've just moved linto my new cell over here on 6-wing .I'm in 6109. My property still hasn't been brought over. This cell is a mess, and I've got a lot of cleaning to do. You can still smell the strong scent of paint. We've got no power in the last seven cells, so no fans, and no power to charge the tablet. So I've got to cut this off, in order to have enough power to sync when we go out this afternoon. They ran rec on the north end. I'm in a fight with ants now. Their coming out of cracks in the wall.I had a cup sitting on the table, looked up, and there's ants all over it! Trying to find all the little cracks and seal them up.

Word is between six and eight guys got disciplinary reports today. And the disciplinary confinement wing is full. I heard it was over the cell inspections. I'm fixing to get up and bathe in the sink, and then lay down. My knee and hip is killing me. I need to see that doctor.

"DAILY JOURNAL" WEDNESDAY MAY 29, 2019

Its still hot and muggy in here, and its 4:00 am. I got up at 3:00am and couldn't get back to sleep. I got up cleaned the cell made my bunk and wrote an email. The scent of paint is lingering longer than I remember it lingering at FSP. Its really strong. Its giving me a headache. We've got all the windows shut, because when you open the windows, the vents pull the hot air in off the concrete right outside the windows., and make it even hotter in here. They built the rec yards in between each wing, in stead of at the back of each wing. Which would have been the smart thing to do. But this is the FDOC, where intelligence runs short!

Well I guess they run rec on the north end. Need to get out of this cell and get some fresh air. This paint is strong! At FSP, they didn't use this black paint that there using on the bars over here. The bars over there are painted blue. I think its this black paint that's got this strong scent. Its 8:04 am, the sun is shining into my cell here on my bunk. I was hoping to see Doctor Toledo today, but that's not going to happen. He told me back in April that he would see me on May 24, and shoot me with a steroid. Here we are five days later and nothing.

Went to rec, it was really nice outside. I got on the kiosk three times trying to fix this tablet. It didn't work. Jpay has some sorry service! I come back in and wrote this email to jpay...

Dear, Jpay Legal Specialist

My emails inbox on my tablet has been disabled since April 20,2019. I've put in three trouble tickets, which has done no good. I've bought a new tablet, the inbox came in about 30 minutes before it went out. What I've been told needs to be done is ... A Flash Feature, which will take the player back to its original settings. I'm sending you this email from my tablet. I can send emails out, I just can't get them in. I've explained this, my inbox says"Sorry your inbox is unavailable" "Please try re-syncing your device" When I hook up to the kiosk, Here's what it says every time I sync"MEDIA PLAYER SYNC FAILED, THERE WAS AN ERROR PROCESSING YOUR REQUEST. PLEASE TRY A GAIN. I've sat there doing it over and over for the whole 15 minutes, and that just keeps popping up. My first trouble ticket #00297243, said the problem would be fixed when I next sync, that was back on like May 6th,as we know it didn't work. This trouble ticket #00310450,said I synced successful on ,May 23rd,no it didn't, it said"Media Player synced failed". It will sync up the games, music, videos ect ect. But it will not sync the emails. I'm not getting my incoming emails. And there's two other men with the identical problem. We need a service specialist tech to come out and look at the problem, or try the Flash Feature. This problem has been going on for 40 days. Three trouble tickets, a \$140.00 on a new tablet, numerous emails, and I'm still without incoming emails. Please see what you can do. I don't want to be without emails two or three more weeks, while waiting on another trouble ticket to be answered. Thank you very much for your time, and hopefully your help.

Well here we are in another day. The strong scent of paint seems to have went down some, or I'm just getting use to it.I'm so aggravated with jpay and the sorry service they provide, or don't provide. Here I am 40 days with a problem they should have corrected, within a week. And it looks like it'll be another week before anything happens. Jpay has been doing this for several years now in different states, you'd think they would have all the bugs worked out, where this thing ran smoothly. Hey, they've got a captive audience, customer's who can't abandon them for better services, so their not worried about providing us piss poor service. Their getting their money. Well we will probably have our second rec today. So I need to get everything ready.

Went to rec, spent my whole time on the kiosk trying to erase emails and empty the inbox in hopes that will fix this problem. Someone said it might. And right now I'm trying everything to get my emails back.

The Col passed out a memo about leaving the mattresses in the cell when you move. The wing Sgt will be in charge of cleaning them before you get moved into the cell. Number one the wing Sgt has enough work to do. So their not going to be doing that. Just like they don't clean these bloody shackles before they put them on the next inmate. Which is probably how this hepatitis c is spreading like wild fire back here. So your going to have mattresses with blood, sweat ,saliva and even urine and feces on them. That we will have to clean without proper bio hazardous equipment. Oh well, I'll deal with it when they move me into a cell. We get moved into these cells that are disgusting!! Toilet smells like piss andyeah! I've seen blood on the walls ect ect. This is no picnic! I try so hard to chill, and then they send out something like this. Its like some one sits around and says, come up with away to make it harder. They filled disciplinary confinement up. One guys over there, cause his shoes wasn't in the right place. I've got to leave it alone. :-) But this disciplinary report will cost the tax payers of Florida several thousand dollars, for a pair of shoes that are in the wrong place. The rules specifically states"

Disciplinary Action will be a last resort". I've got to get my mind off of this, cause I'm a nats ass from writing some senators. This is why they come after me all the time. I don't speak, I write. And I'm so trying to chill out.

Been fighting the ants off. There's a hole in the floor under the sink. And ants and other bugs are coming out. So I had to clog that up. I've washed up and ready to call it a day.

Woke up at 2:58 am. Hip and knee is hurting. Had problems getting to sleep because of the pain. And the thing about it, medical want do anything. I've got to go to the law library this morning. I finally stopped the ants last night. I had to sprinkle powder all over. For some reason they don't like baby powder. But I've got to get maintenance in here to patch the hole under the sink. Most of these cells have gaps in the back wall. This building is falling apart.

Went to the law library, as soon as I stepped off this wing, I'll bet the temperature dropped fifteen degrees. Its nice up front where the officers are.I found out another tablet on the other side of the building is doing the same thing, and he did the flash feature. It worked for one day before going back out. I don't know anything about computers, so I have no idea what the problem is. Also one of the guys placed on disciplinary confinement, is blind. I heard he (the blind guy) had trash in the floor. The guy is ADA certified. Oh well. I've got enough battles going on right now with medical, and every time I stick my neck out, I stand alone. And I've got to get this medical treatment.

Been along day. I just got back from the shower. I'm tired and going to lay down. Doubt I'll sleep much. I'm hurting!

Well here we are in June, half way through the year. Seems like it was just new years day. Time flies yet drags. Contradiction.... but that's how it seems here in this cage.

Its been another hot day. Had another bad night of pain. So this morning I reached out to serval people and organizations to help me fight this sorry medical company. Then I wrote several pen pal organizations, to try to find a few more people to write, which is within the rules. Wish I could find some new organizations to write.

Went through trying to straighten out some of this legal work they messed up last week. Its a mess, beyond repair. I ran across several names of guys who have been executed. Mike, Catfish, Jose and Eric. Yeah its a mess looking back on all the guys who've been killed by the state.

Seen on the news another mass shooting. I don't get it, why people do that. Something is really wrong with society! These mass killings are becoming way too common! These violent video games or movies maybe contributing to this. Desensitization, you see it so much, that you loose touch with reality. You don't see them as people. These guns need to go. People should be able to own a revolver, five shot rifle or shot gun, but these assault rifles need to go! There for war! For killing people! I'm tired of seeing these people get slaughter and everyone disregards human lives, for the second amendment. Believe this, our forefathers wouldn't have implemented the second amendment, if they could have seen what it has come to. Cause it was written into the constitution at a time that it was need in order to protect this country. Its no longer needed, and on longer useful. Why? Because we've got the National Guards, ect ect!

Watched 30 for 30 with Janet Guthrie, the first woman to race at Indy. Was a really good program. Screwed up the way society treated her. Life isn't fair, and that can't be argued.

Woke up at 2:00am, couldn't get back to sleep. So I got up, washed up cleaned the cell made the bunk and started my work out timer. Every twenty minutes I'm doing twenty five pushups. No matter how bad it hurts, I've got to get back in shape. This cage will tear you down!! This crap destroys you both physically and mentally! Just pushes you over the edge. And some, well they fall over that edge quicker than others. Like for instance, this cage I'm in, one of the guys at some point, scratched the mirror out. Its a metal mirror, but someone thought it was a two way mirror, and that someone's looking in at them, so they've scratched it out. So you can't use this mirror. I've heard guys say there's camera's in the lights, TVs, and now even in these tablets. And they've tried to convenience me of that, and I found myself looking and then thinking ,"What are you doing?!"Its a nut ward back here. I know this crap is taking a mental toll on me, that I don't even realize. Really I'm just trying to hold on to what little sanity I have left. I know I'm not as far gone as a lot of these guys. "Civilized society! " "Evolving standards!" Where?? All I see is mental torture! In humane treatment! Cause I'll tell you what, if you put an animal back here in this cage, in this heat, and only walk that animal twice a week on concrete, you'll have ten thousand animal rights lovers out here protesting. Oh don't get me wrong, they would be rightfully doing so. Cause no animal would deserve this type of inhumane treatment. Hell I'd be out there with them demanding that the animal not be caged in a heat box, and only walked twice a week. But my point is, there's three hundred human beings back here caged up like this, and not one single protestor! Population inmates, they've got temperature controlled environments, and their not stuck in a cage all day. And there's guys out there, who have committed worse crimes than guys back here. But for one reason or another, they didn't get the death penalty. Oh this is the most arbitrary and capricious sentence given. And the facts, statistics back it up!!

I'm really tired, but its also very hot in here. I am about to lay down and call it a day. Hopefully tomorrow my inbox will be fixed where I can start receiving incoming emails.

Woke up at 2:00 am, but didn't get up until 3:00. Tossed and turned a lot last night from the pain in this hip. It runs all the way into the knee. My chest shoulders and back is a good sore from all the pushups yesterday. I'm going to be getting started here shortly. Hope to go to rec today, and that this email will sync with the kiosk, and fix my inbox.

Well no morning rec. They may have called 4 and 5 wing. Still a chance we could go this afternoon. Seen more on that Virginia Beach massacre. The worse part about it, it want be the last. This has become a cycle. And no one has the answer to what its going to take to stop it. And gun bans... well that's not going to happen. Gun manufactures are too powerful. And when it comes down to money verses lives, money will always come out on top.

8:28 am Grievance lady just picked up my medical grievance. 4 and 5 wing went to rec this morning.
We may go this afternoon.

11:03 am Sgt just came down saying there's rumors of a cell inspection. So now everyone is sitting around waiting on that. If it even happens. Half of the disciplinary confinement wing is full because of the cell inspections. This was implemented in 2016, but its never been pasted as a rule. Which is required by Florida Statute §120.54. But no one has tried to challenge it. I don't have to.I've got enough battles going.Primarily medical is where I've got to stay focused. This place, if you could hear it, you'd swear its an insane asylum. One guy, when he hears someone say something, he repeats it. Right now he's watching a talk show and repeating what their saying. I can't slide under my headphones and block him out with music, because then they may come by with cell inspection, and if I'm sitting here with my headphones on, then I'll go to the disciplinary confinement wing. "Welcome to my insane world!!"

11:29 am We were told to stand down. See the problem is, they've got the officer's so jumpy, that any time they come in the building, officers think its a cell inspection. what an existence! Caged up,warehoused in conditions worse than an animal shelter!! And you've got these people, who basically come through taunting us. I see it no different than a person visiting a zoo animal. And they see the animal being peaceful and sleeping, and you yell,"GET UP!!" Just to get a reaction. Cause during these cell inspections,they don't come around and say, How is the water? Is everything okay? Do you have any problems? None of this is done. We really need this to be placed into Chapter 33-Florida Administrative Codes, so staff and inmate's know what is expected of them. As it is, I've seen numerous changes over the past three years.Basically every time a new warden or administration takes over. I'm not pushing it, like I said, My plates full! I'll only push it if they ever write me a DR. They just called us for rec., so I'm going to have to post this. The kiosk may wipe my tablet clean. Fingers crossed that it works.

Its been along day. I got up at 2:00 am. We had to sit around waiting on cell inspection. After that I was able to start my pushups. Then around 11:00 am I went to see Nurse Mauk for sick call. I seen where Doctor Toledo wrote down about what he was going to do. Nurse Mauk remembers him saying that he was going to get my celebrix back, give me a shot on the 24th of May. And put me in to be seen by the orthopaedic specialist. He lied about all of that. Centurion medical corporation is more concerned with making money. They aren't trying to spend money on us inmates. I got a feeling that this is going to be a major battle. Media Senators, and to do all that.... I can't give away my hand, yet. I'm going to have to put together some letters. ARNP Collins is going to see me Thursday or Friday, according to Nurse Mauk. But he's argumentative, combatant and I really don't want to see some incompetent nurse who's trying to act like a doctor, and has the personality of a brick! I've already filed a grievance on ARNP Collins. Well dinner didn't show up until almost 5:30. I'm heading for bed now. See what tomorrow holds, if I see it. One thing about it, its not guaranteed to any of us. Wouldn't break my heart if I didn't see tomorrow. For tomorrow is a repeat of today, and every other day. Welcome to hell on earth!
