HEY. I HOPE YOU ARE DOING WELL!

TODAY I'M GOING TO SHARE WITH YOU SOME CHANGES THAT HAVE BEEN MADE TO HOW I, AND EVERYONE ELSE HOUSED ON DEATH ROW (MALE), LIVE.

BUT FIRST I WANT TO INFORM YOU OF THE SCIENTIFIC CONSENSUS ON THE EFFECTS OF LONG-TERM SOLITARY CONFINEMENT. IN SHORT, A

COMPREHENSIVE META-ANALYSES OF THE EXISTING LITERATURE ON SOLITARY CONFINEMENT WHETHER AND

BEYOND THE CATEGORICAL JUDGMENT SEEING FOUND THAT THE EMPIRICAL RECORD COMPELS AN UNMISSABLE CONCLUSION: LONG-TERM SOLITARY CONFINEMENT

CAUSES PSYCHOLOGICAL DAMAGE. NOT A SINGLE STUDY OF SOLITARY CONFINEMENT, WHERE THOSE CONFINED THAT LASTED MORE THAN 10 DAYS, FAILED TO HAVE ANYTHING BUT NEGATIVE PSYCHOLOGICAL EFFECTS.

A RESEARCHER ELABORATED THAT ALL INDIVIDUALS SUBJECTED TO SOLITARY CONFINEMENT WILL EXPERIENCE A DEGREE OF SORROW, DIFFICULTIES WITH THINKING AND CONCENTRATION, OBSESSIVE THINKING, AGGRESSION, IRRITABILITY AND DIFFICULTY TOLERATING EXTERNAL STIMULI. ANXIETY AND PANIC ARE COMMON SIDE-EFFECTS. DEPRESSION, POST-TRAUMATIC STRESS DISORDER, PSYCHOSIS, HALLUCINATIONS, PARANOIA, CLAVICULOPHOBIA, AND SUICIDAL IDEASONS ARE ALSO FREQUENT RESULTS.

THAT'S WHAT WE ON DEATH ROW ARE FACED WITH. IN FLORIDA AT LEAST. SOME OF US CAN HANDLE IT BETTER THAN OTHERS. WE'RE LEARNED HOW TO COPE WITH IT THROUGH SURVIVAL. BUT THE NEW ADMINISTRATION IN "THIS" PRISON HAS TAKEN AWAY OUR SURVIVAL.

WE HAVE pop-up inspections where we have to have all our property put away in our lockers. Including putting our dirty clothes, we wash clothes/towels and trash also have to be put away in our lockers & has to go to, possibly contaminating our clean clothes, paperwork and...

... "FOOD": we have to be fully dressed in our orange denims, bed made military style, t.v.-off and standing at the back of our cell with our hands at our sides. Of course we don't have to turn off t.v.s and stand at the rear until they're on our hall, but until they come around and tell us to stand down we can't do anything.

Lang works on our cases, draw, wash... and stuck in our hot uniform in 90° temps. These last couple weeks 95°F plus, (35°C plus) and if anyone makes a "mesaice" and "forgess" to put their hygiene items (toiletries paper, soap, toothpaste + brush) on the corner of their bunk, leaves a washrag hanging up, t.v. on, shirt unbuttoned... we're given a D/R (Disciplinary Report) for disobeying an order, that's right... if we make a "mesaice," we with some degree of mental illness from long term solitary confinement, we're given a D/R as if we did it intentionally. In short, we're punished for having psychological problems that prevent us from performing most military precision. Bed not made right? D/R! If can't even pass over on the wing and it's not put up 3 minutes later and an inspection crew comes

ABOVE?? DJR! Yup, THAT ACTUALLY HAPPENED TO SOMEONE HERE. THERE'S AN ASSOC GUY HERE WHO CAN'T HEAR SEVERAL LEGGERS (SYLLABLES OR SOMETHING)... HE GOT A DJR FOR NOT BEING INSPECTION READY! HE DOESN'T EVEN AGREE! I, MYSELF, WENT A LONG TIME WITHOUT GETTING IN ANY TROUBLE. I WORKED HARD ON MYSELF TO BE ONE WHO FOLLOWS THE RULES... AND I GOT A DJR FOR FAILING INSPECTION. WE (MY MATE) WEREN'T EVEN TOLD THERE WAS GOING TO BE AN INSPECTION. AND EVERYONE ON MY MATE'S SIDE TOLD THE WARDEN THAT AS HE WALKED DOWN THE HALL, 4 OF US GOT DJRS THAT DAY. 20 DAYS IN THE HOLE (SEGREGATION WING) WITH NO PRIVILEGES. AND ON ONE OF THE NIGHTS BEFORE THE SGO LEAVES THE LEGGERS ON ALL NIGHT. PEOPLE THERE GATHERED SO BUT HE DOESN'T CARE, HE WAS TOLD TO SOUP SIC.. IS SOUP AS SOUP? THE SGO THAT DOESN'T TELL MY MATE ABOVE THE INSPECTION LEGGED AND DOWNSIDE DOWN ON HIS LEE BY SAYING HE TOLD US SEVERAL TIMES TO BE READY. BUT I GUESS, SO HAM, SO WAS BETTER WE GET IN TROUBLE THAN HAM.

ANOTHER WAY OUR SOURCE HAS BEEN TAKEN AWAY FROM US IS WE NEVER KNOW WHEN WE WILL GO TO YARD. THEY ONLY GIVE US A 15 MINUTE - 30 MINUTE HEADS UP. SO WE CAN ALREADY BE INDOOR SWEATING CASE WORK, ANYWORKS... AND UP POPS A YARD CALL. NO TIME TO PREPARE FOR EXERCISE AND THE BLAZING SUN THAT'll BE BLAZING IT'S SOMETIMES 98°F ($36\frac{1}{2}^{\circ}\text{C}$) HEAD DOWN ON US. PEOPLE GET SICK OUT THERE. NO SHADE AND ONLY

WARM WATER FROM A WATER FOUNTAIN TO HELP KEEP
US COOL. WE GET APPROXIMATELY 3 HOURS AT YARDS.
TWO OR THREE TIMES (TWO OR THREE TIMES)
ANNUALLY. WE USE 10 GEO MAKE UP YARDS. NOW
IF WE HAVE A LEGAL, MEDICAL OR RELIGIOUS CAUSE
AND YARD IS AT THE SAME TIME, WE MIGHT NOT
GET A MAKE UP YARD IF WE CHOOSE TO GO OUT OF
CAUSE. SO WAS AN ORDER BY THE COUNCIL THAT
THEY HAVE TO GIVE US MAKE UPS IN THOSE
SITUATIONS. BUT... OTHER CURRENT ADMINISTRATION
DOESN'T CARE ABOUT THAT. THEY'RE IGNORING THAT
ORDER AND HAVE NOW IMPLEMENTED A NEW PROTOCOL.

IF I HAVEN'T GOT A MAKE-UP YARD I'M OWE
DURING THE MONTH I WAS SUPPOSED TO GET 10, SO
MILL NOT ROLL OVER TO THE NEXT MONTH. SO NO MAKE
UP. I HAVE ONE FOR THIS MONTH AND I HAVEN'T
GOT 10 YET. IF I DON'T GET 10 TOMORROW THEN I'M
SCREWED OUT OF THAT EXERCISE OUTDOORS. I WAS
SCREWED OUT OF ONE LAST WEEK AND MORE THAN A
DOZEN OVER THE LAST 2 YEARS.

I'VE CURRENTLY GOT GRIEVANCES IN ON THESE
ISSUES ASKING FOR CHANGE... TELL YOU KNOW IF
WE GET 10.
