INMATE HEAT PASS

1. Take your prescribed medications unless told not to by the doctor.
2. Don't take aspirin, Tylenol, Motrin, Excedrin or Bufferin.
3. Drink more liquids (water, juice).
4. Don't drink coffee, tea, or colas.
5. Don't do hard exercises.
6. Stay out of the sun.
7. Shower or wash from sink often.
8. Stay in contact with others.
9. If you are in the sun, wear loose, lightweight clothing and protect your head.
10. Stay away from areas with poor airflow.
