So many times we think when a women sentenced that is the end of the story. But not here in Georgia. Some inmate such as I comes in saying I am going to do what these people tell me to so I can get home to my family. How many know in society know of their love ones doing that but their female relative has yet to make parole. She don't get into trouble. She tries to follow the rules. Just a peaceful inmate. When is good enough for the correctional officer, Warden and Deputy Wardens and counselor who oversee us everyday. If you follow the rules the officials don't like you. Which I would personal think at least that inmate is not a problem. But no that is not the case here. Since you're not a problem, they will create a problem for you, make you look you are a problem. The thing about women as a mass they are afraid to stick together on grievances or any procedural because they are afraid of retaliation from the staff. Standing up for your rights is not disrespectful. But the fear keeps them from speaking up or getting help at Pulaski State Prison. SOP says staff is not to harass, retaliate, or provoke inmates. Do inmates suppose to do what they want absolutely not. Do inmate building should be single out all the time because they got a few bad inmates in that down absolutely not. Those types of inmates are just about everyday on Pulaski State Prison Grounds.

Is everything taken from them down because of a single act
by few people absolutely not. I am tired of every down I
live in. Is always been harassed by officials who don't like
~~me~~ me because I think I am little ~~more~~ perfect. My mind set
was to do what I suppose to get home to my family. When I
lived in F-2, E-2 it doesn't matter they would find some reason
to harassed that down. somebody can cough wrong. Here comes
the threats and harassment. They are quick to send us to
our cells without ice or hot water for hours. Standard
Operation Procedures says we can only be locked in our
room for 2 hours at the most. I guess you say their prison
that are lock down 23 hours. Pulaski State Prison is not that
bad where you have to do that. Every once in a while you
might have fights etc. It does has some hazing. It appears
that people who is causing the troubles in the dorm. Does
it especially in E-8 and E-9 because they know everybody
is going to get punished. Right their is how a repeated
offender is created in system because why they are not
being punished for their wrong individually and not
learning no lesson. For the ones who are being punished
along with them even though they are innocent. You are
creating a angry inmate to enter back into society
angry and bitter at everyone because they have suffered
so much injustice behind the wall. They have become
numb to people, who they are as a person and to others
well being. I used to wonder why certain people come out
of prison angry act like a wild animal out of
control. Now I see how they are treated ~~by~~ behind
these walls.

They loose hope because when they doing what they suppose
they are treat like trash behind these walls as if they
are nothing but trash from the scum of the earth. What does
mass punishment looks like. 06/23/19 Sunday I work
on weekend kitchen. So everybody trying to get the kitchen
clean so we can hurry back to see the BET Awards. We
~~sots~~ did it. yeah! Somow the inmate are happy to get
back to the dorms. take a shower, fix something to eat
and set down is watch the BET award except for building
E9 they had been on mass punishment for a while. So I
live in the other dorm E-8 they like to mass punishment.
I get to my dorm people hollow out the window we
lock down. I saw like what they begin to tell what
happened. I had noticed this new officer in the dorm
had come with a already sabotage attitude against
the dorm early that morning. Because what the officers
do and staff E-8 and E9 they think they run something
I am going to show them who is in charge. When E-8
is not that bad. So the officer told me go to your
room you all on locked down. Mind you I am
just coming from my detail. I said could I take
a shower no go to your room. No ice and water etc.
I had to convince the lady to take a shower. I said
main what happened why are we on lock down. Quot
she not going to argue with inmates. The inmates in
the building said the officer mash the access button
and they came out some of them. They seen inmates
walking around in dorm E7 and on the walk. So they

My suspected count was clear because those inmates was out. The officer tried to send the inmates back in the room stating count has not cleared. Instead of her calling to see if count had cleared. She called security talking to Deputy Warden of security making it seems like the inmates was just doing they own thing and refuse to day her. They was arguing with her. Which this same officer has had complaint about her in E-4 and E-5 because inmates do talk amongst each other. at Pulaski State Prison is always the inmates fault for everything. When sometimes actually it the officer fault. 58 06/23/19 Sunday took our TVs and made us go to bed at 9pm (two week store restriction) Could only buy legal and personal supplies off the store. E-8A and B 06/25/19 The Warden, Captain and Deputy Warden of Security took our tablets E-8B and A 06/25/19 The Warden, Captain and Deputy Warden of Security Shook E-8B side down 06/27/19 Some one broke into another inmate locker. nobody didn't see who went into the room. The Lt. put the whole dorm E-8B on lock down. I came in from the kitchen. I ask to take a shower the Lt. told me to bath in the sink. plus we was in restriction to go to bed 9pm. I had to beg the next shift officer could I please bath. Everytime we was inmates stress when someone do something it has nothing to do with the next inmate. we didn't come to prison with them. They say we are a whole.

How is that individual going to learn from their own mistake. The prison are creating repeated offenders and angry inmates. Because of the mass punishment and harassment and some of them will try to provoke you by how they talk to you especially our Deputy Warden of security. He be rude to inmates all the time. One lady said sir what have I done for you to be rude to me. He locked her down. Pulaski State Prison has went down. I just choose to be quiet and speak out in different way. Doc needs to do something different with staff at Pulaski State Prison and how it's ran. Some of us give the staff the upmost respect and follow the rules but do we get it back instead we get mass punishment
