Prologue:

In recent years, we have all seen and celebrated an end of the use of Solitary confinement throughout the California Department of Corrections and Rehabilitation.

We are aware of the agreement between representing Prison Gangs, Prison Subcultural groups, and Department officials for the end of hostilities between the races.

In response to the Department's 50/50 program merging that has also ended SNY culture, which is primarily Sensitive Needs Protective Custody Status in the State, the very subcultural groups that agreed to peace, have now agreed amongst themselves to purge Prison yards of all inmates that would otherwise be assigned as SNY.

With the assistance of Corrupt Correctional officers, this New agreement now includes the physical abuse and program exclusion of inmates that openly identify to some degree as LGBTQIT, in a cowardly attempt to force the Department and an LGBTQIT supporting Governor Gavin Newsome to end the 50/50 program evolution.

In April of 2018, Billie Mizell was invited to attend ongoing sessions of a group founded by this writer titled: SQSP/Condemned LGBTQIT Spirituality Group.

Billie Mizell introduced herself to our group as an activist for the equal protections of LGBTQIT persons, and was volunteering inside of SQSP to bring her LGBTQIT Curriculum, into The Department through a Mainline Group titled ACT, acting with compassion and truth.

When this writer asked Billie Mizell to help our group and assist us in our vision for the creation of The Sound Mind Streamer Media Center Broadcast of Urban Perspective LGBTQIT programming to educate, build awareness, and to end the ongoing violence of Gay inmates on the Campus of SQSP in Donner Section, Berger Section, and Alpine units, Billie Mizell, not only agreed to help, but in one session even stated that at the end of a said session, she was going directly to ~~the~~ Shop to purchase equipment to reformat the Sound Mind Streamer content to DVD-R and get the DVD-Rs played at SQSP Media Center.

Today, as we fast forward into the year 2020, Billie Mizell has done zero to bring and end to Gay inmates being beaten, and having human feces and urine and dirty used condoms thrown on them by subcultural prison inmates.

Billie Mizell has not presented one DVD-R of Sound Mind Streamer Content to the SQSP Media Center for Broadcast, and lied to NBC News public Media stating that our LGBTQ+ Spirituality Group was in fact a replica of her mainline ACT group with the permission of CDCR.

Billie Mizell even attempted to convince this writer from removing (LGBTQ+) from our Groups title, and was allowed to visit me at cellfront without escort to solicit statements from me and members of our group to outside public Media sources on behalf of her ACT program which has never, and still does not exist on Condemned Row.

Hello, my name is Floyd Smith #K72700, I am a Condemned Inmate since 1997, Black and openly Gay, and have never heard of Billie Mizell until April 2018, while she was attempting to steal our historical first ever SQSP Condemned LGBTQ+ Spirituality Group away from the most underserved inmate population at SQSP.

In the last 20 years, the California Prison Openly gay male population has been reduced to zero visibility.

Today on the Condemned Population on the Campus of San Quentin State Prison, only one person out of 750 people on the Row identifies as Gay.

In a 2019 For Hustle Podcast titled The Down Low, it was reported that out of all inmates on the Mainline Campus of San Quentin State Prison, NOT one person identifies as Gay.

That means that out of nearly 4,300+ people, only one person identifies as Gay, at San Quentin State Prison.

Since 1997, this writer has been "The One."

For over 18 years, I have, through a plethora of levels, struggled to bring social awareness to the absence of programming and resources, and security issues to the Campus of San Quentin, and on behalf of a "crowded closeted" New generation of urban perspective Gay inmates, my efforts have been met with disdain, passive ignorance.

For example, In an ALL Male Prison, we have seen since 2016 the presence of volunteers that present as Lesbians, introducing non-accredited label lessons, Transsexual services, and Womens issues programs.

Although Trans inmates only make up 1% of the prison population, through Court Cases, and other legal filings, the entire focus for LGBTQIT resources are all, 100% designed to serve Transgender people.

By default the LGBTQIT Movement is now being headed, and controlled, with specific design to serve the T, and totally exclude The G.B.Q.+ persons at San Quentin.

Today, as I write this, EVERY person who is assigned to be housed in Boger Section, and Donner Section at San Quentin Prison, and identify to some degree as Gay or Bisexual are automatically required by all Subcultural groups of inmates to roll up property and request to be re-housed in Alpine Section, Protective Custody Status,

The above version of inner prison Sexual Orientation Discrimination and Segregation is amplified by physical abuse, beatings, being deuced with Human feces, urine, spit and dirty condoms, and to date, there is no Lesbian volunteer program design, OR Heterosexual Custody Officer Service Program, NO PREA, OR ACLU investigation or response, nothing, no prevention and awareness based programs, no Mental Health OR Religious Department Service programming, no LGBTQIT intervention, no accountability, nothing.

On or about May 26, 2019
 about 4:44 pm the Lesbian
 delegation took the disrespect to
 a new level by telling an
 NBC News Reporter that;

"This year, the California Department
 of Corrections and Rehabilitation
 allowed volunteer Billie Mizell
 to replicate Her
 acting with compassion and truth Program
 on San Quentin's Death Row, That
 Group, comprised of five people,
 meets Tuesdays, it's not open
 to reporters!" (NBC Reporter Sosin)

Billie Mizell lied to NBC News as
 this writer founded That Group, which
 met on Tuesdays before a Jewish
 Rabbi invited Billie Mizell to attend
 the sessions.

That Group, is The San Quentin State Prison's
 Historical first ever Condemned
 LGBTQ+ Spirituality Group, under
 the Religious Department, and not
 PIA = Prison Industries' Vocational
 Department, PIO.

Billie Mizell's flagrant disregard to the
 Department's Religious Spiritual Community,
 that was specifically created for the
 social and spiritual well being of the
 most underserved demographic of the
 Prison Campus amounts to the attempt
 to deny Gay inmates access to Religious
 programming under safe conditions.

Billie Mizell's ignorance to Department Policy, and misuse of Department's resources, and unethical conduct by default exacerbated the ongoing levels of physical abuse of Gay and bi-sexual inmates by attempting to manipulate prison officials to adopt a non-accredited curriculum as authenticated.

(for example)

Billie Mizell's lack of knowledge, care, and attention to the ongoing violence against Gay prisoners for simply identifying as one or more of the very labels in her unaccredited curriculum, serves as the very reason labels are misused by prisoner subcultural groups.

Billie Mizell ignored my personal attempts to educate her that HER outdated program model is being used by Prison Gangs and subcultural groups to prove a disconnect to race and cultural identity of inmates that attribute the label assignments, and homosexual identity as a "White Men's" intentional agenda to demasculate the non-White men's masculinity around the world, and on this incredibly ridiculous claim, the abuse, and harm to Gay prisoners are validated, in prison culture, in real time.

I even began to teach Billie Mizell that her program model for the solicitation of Empathy of the oppressor of Gay people is trumped by California State laws for the equal treatment of all Californians which require no Empathy from any oppressor, and there exist a wide range of LGBTQIT, and Straight Allies that has already fought for my right not to be spit on, have human faces tossed on my Gay Brothers, to be allowed to participate in Religious and Spiritual Programs without being assaulted, threatened, called an Abomination and Infidel and be required not to partake in the Ceremonial Pipe Smoke and Smudging Ceremonies as an open Gay person in a predominantly Gang Controlled Native American Indian Spiritual Program; I presented real time accounts of violence, and to this day, Billie Mizell's focus remains to propel herself into a legacy story where she is, unworthy of a prison population's attention, because she is still, MIA on the intentionally ignored Human Rights Violations against Gay people at San Quentin State Prison. Billie Mizell's presence on any prison campus threatens the safety and security of all unsuspecting LGBTQIT inmates.

For those of you who are invested in the positive development of our youth, I require that we all create a paradigm shift into providing more Affirming and Confirming Services for the oppressed as well, as they are also in attendance in this teachable moment.

Education, and access facts is the number one problem solver for all humans.

#1. Every inner prison subcultural group that abuse Gay people share two things

a) Hatred for Gay people based on learned behavior of fellow group members and shot callers.

b) A respect for Race, Culture, and History from an ethnographic perspective.

#2. I created The Sound Mind Streamer as a Spiritual, Educational and Morale Booster for Gay incarcerated Americans.

a) Media Center Institutional TV Channel provide a safe environment for all interested inmates

b) Provide Same sex Historical presence Content of all Race, Cultural, and Ethnographic perspectives.

A prison Gang Shotcaller is not interested in Billie Mizell's label version lesson that is Eurobized, yet, every single Gang Shot caller, and Gang-Member, Muslim, Christian, Asian, Mexican, African and Indian, Russian, Scottish, Pacific Islander will at least, and out of respect, will view The Sound Mind Streamer when we broadcast programming where people tell their own stories about the many versions, and words within their own language and ethnographic descriptions that induce pride, and the liberation of facts that becomes a mirror of truth that hatred can not explain.

The Fair Use Act of 1976 is our window into the end of the physical, spiritual, and abuses of exclusion based on ignorance, and enslaved facts.

when I'm able to tell the difference between Billie Mizell, and prison Gang members, I will down shift, and focus on The Sound Mind Streamer exclusively, but until then, welcome to 2020 where care for all LETZ GO people is required to the social and economical degree of Equity.

The irony here for me is I'm responsible for the wellness of all LGBTQIA persons just like Billie Mizell should be, including those of you reading this body of work, and for me it means that hearing my Family that identify as Lesbian say that our history, in the beginning was very exclusive to them, by Gay Male idiots, and then actually experience a Billie Mizell replicate said ignorance against Gay Men is worth another look in the mirror as a people, and the word, Equality.

Billie Mizell has never, and will never be what I am, and open, Black Gay, Incarcerated Male in an Urban perspective reality, and where empathy is not required.

Some Men are made for Men,
 Some of us are Black, Masculine,
 and have no desire to be
 a white woman. Some of
 us are Human, and from the
 Hood life everywhere, and
 demand to be treated equal,
 and with dignity.

For those of you that continue to create a label table, I admonish you here, that it would behoove you to teach our youth about Karl-Marx Kertbeny, and the origins of labels like Homosexual and Heterosexual and understand that equality is the only replication required.

And it doesn't matter who you are, your privileged class, your powerful friends, or agenda, my primary focus will be to prevent you from interrupting peace with your Bullshit.

To my fellow LGBTQ+ Incarcerated Americans, Billie Mizell told me personally that she is trying to expand her program throughout the state, and all of you can maintain your right to be free from being used to misuse the legacy of true LGBTQ+ freedom fighters that put the people first, not self.
