If it wasn't for that love, me wanting to take care of her because of the love I had for her, and her mom, I would have left then. This relationship was built on a foundation of lies and manipulation anyways! She admitted it on Sunday February 25, 2018 that she got me through manipulating me. Oh yes I told her jokingly that I was going to write the date down! I did as you can see. When she through a fit and walked out on January 21,2018, I should have nerve let her back into my life after that. Again I put my judgement and common since to the side, because of misplaced love!! My stupidity! I seen how self-centered she was, and I kept making excuses. Yes there's a thin line between love and hate. And she's the only woman that ever crossed it. She cheat on me with a so called friend that I'm trying to get her to help with getting his visits and rec back. Then he does this!!! And I'm the last one to find out! The officers are around here reading our emails, laughing at my stupidity. And then this guy "so called friend" outs her in a note that he sends to me. Wow! And then she trust him?!! And all the guys around here know, and can't believe she's so stupid!! Guys have seen Clo and said ,Dog you up graded big time! And the women in the visiting park have been talking straight shit about my ex for the past several weeks. She's made us the laughing stock of death row. Yes that song by the Persuaders I've heard it thousands of times growing up, but never truly understood it until now. Now I complete grasp what their singing about. Yes this last relationship was so toxic from start to finish! And it was one I should have never got into. Yes I walked out and broke up with her on Sunday July 21,2019 disgusted with her lies but more so with her cheating on me. She said, I don't see how your taking it so well, I cheated on you! Well I wasn't taking it well! But I truly loved this woman with all my heart. And because of that, I overlooked so much! I kept trying to put it behind me, and show her "UNCONDITIONAL LOVE". But cheating on me, that was the straw that broke the camels back! Mrs Mahoney stated she (my ex,)will have to wait six months before applying to get on this other inmates visiting list. I then filed a grievance on it, again quoting that rule. Assistant Warden

Well on Saturday February 22, 2019 I'm sitting here in my cell, when I start hearing that my ex came down from Oklahoma for the weekend, came into visit, and at approximately 12:30 pm was escorted back out, and the inmate was placed on disciplinary confinement for violating the rules. To me, it was POETIC JUSTICE!!! But it goes to show that the FDOC wants us to follow rules, that they themselves fail to abide by. For she should have never been allowed back in here! This is two different standards set for all. The administrations excuse, oh we don't know her (my exs) intent. Well that's a boldface lie! She contacted classification and questioned them about getting off my list and getting onto his visiting list. So they had absolutely no excuse whatsoever for violating this rule that was put in place, in order to protect the safety and security and good working order of this maximum security facility. Correctional Staff, visitor's and inmate's have been running around here talking about this for the past several weeks. Talking about how she should have never been allowed back in here, and how this had the potential to get someone hurt. This drama, was created by my ex, with the assistance of the prison administration. What were they thinking? Imagine your cheated on, heart broke, you walk into the room and there's this so called friend holding the woman you loved? That's enough to push someone over the edge. That's why the rule was put in place.

Bottom line is this, my ex friend and ex girlfriend put a spot light on their self, by their actions. Sending emails getting off and on Jpay and creating all this drama. So its your fault, that their now going to enforce this rule, not mine. So don't blame me for your mistakes. Your no longer permitted to get on my Jpay email account. So stay out of my world! Stay out of my life! Leave me and my beautiful fiancée alone!
