Subject: SURVEY ON THE EFFICIENCY OF R & R

The Inmate Advisory Council (IAC) conducted a survey to obtain the General Population's opinion on the efficiency of R & R, and to obtain any suggestions for improvements. 522 Inmates of the 750 answered the following survey in this regard: 99 responded as BAD; 138 responded as GOOD; 285 responded as NEEDS IMPROVED. Many of the latter also circled "BAD"/NEEDS IMPROVED, or circled GOOD /NEEDS IMPROVED, which I had counted in the NEEDS IMPROVED category.

Survey comments in the NEEDS IMPROVED category include: "We should be allowed 2 pairs of shoes. I've never seen R & R write down a shoe code, but here"; "All inmate property should be given to them upon arrival"; "R & R needs an open line of communication. 22 Forms go unanswered and R & R c/o's don't have time when they are on the yard to answer questions"; "Packages are fast"; "Needs improved - especially in regard to how new arrivals are treated"; "Need to stop theft of property"; "Need Tablets"; "Need to acknowledge more than 3 appliances"; "First off, may R & R stay be well (sic). Secondly, I truly do understand the energy exerted by R & R Staff, but I personally came here alone and it would have been nice to get my property that day"; "Needs improvement in the area of not giving Inmates a hard time when exchanging Inmate property items (cloths/shoes/accessories) with one for ones"; "Any other prison you bring any shoes to turn in. Shoes that we are forced to turn in could be given to others in need"; "R & R needs to stop sending our packages back after the company sends them"; "Packages are being sent out in the correct quarter but delivered in the next quarter, and counts as that quarter"; "We wait nearly 2 hrs. in line"; "Should use ducats"; "More accessible, twice weekly"; "Don't respond to 22 Forms"; "Need a better time line schedule on how to get things done"; "They keep on asking for 20 year old items. Stop stealing shoes/accessories/cloths, by not having them to exchange"; "Needs more efficiency in distributing our packages upon delivery"; "Call workers at night""; "Pass out property from incoming transfers on time"; "Tank-top shirts shouldn't be counted on property card as a shirt like other prisons"; "R & R needs to call inmates for packages a lot faster. Packages sometimes sit in R & R for months. There's no excuse for a month old package when DOM specifies 15 calendar days"; "Run packages more often please".

Survey comments in the GOOD category include: "R & R is very efficient"; "Counting a portable radio/Walkman as one of the three appliances does not make sense"; "Please process and issue personal property faster upon arrival here at MCSP, (it took me a month)"; "R & R don't (sic) issue 1083 receipt"; "I have a court order for my legal property from R & R. I've been here since Nov. 19, please contact Lancaster for my property".

Survey comments in the BAD category include: "Return/Deny package for invalid reasons"; "Count packages for the following quarter, even though they arrive on time"; "Utilize 3/W also to deliver packages"; "Slow delivery"; Never answer 22 Forms"; "Too anal on the one for one items and only 3 appliances"; "Waiting for packages 3 weeks"; "We should be able to return to our housing units to get turn-in items, and get packages the same day instead of waiting 'til next time they call you. Also, they're not allowing us to send home art/hobby works that is bigger than 12"X12". That's the purpose of going to R & R to send it to loved ones off your account"; "Some inmates families order our packages without us knowing, thus we don't know if we need to take turn-ins with us"; "My 34 years of CDCR experience informs my opinion that MCSP's R & R Dept. constitutes the old adage of The Tail Wagging The Dog. This is to say that R & R is a part of the prison – not the other way around. However, R & R here seems to aspire toward becoming an Independent State. We all suffer because of this policy"; "In the past two and a half decades of my career I've never witnessed any other R & R Department so far off policy".

And this writer's personal favorite from an anonymous individual who didn't check off any particular category, but thought his opinion mattered anyway who wrote: "I believe this survey was a waste of time, conducted by a psycho who just wants an excuse to walk around and act important".

The IAC wishes to thank the population for their thoughtful participation in this survey, and we assure you all that we are doing what we can to improve conditions here at MCSP in 2020. Please feel free to approach any IAC Representative with your concerns about our program here and how we can work together to make it better for everyone.

In closing the IAC would like to invite R & R to meet with the IAC so that we can resolve any issues that R & R may have, so that this survey does not appear to be one sided. Also, we do appreciate the cooperation with R & R to make Mule Creek State prison more efficient.
