Anxiety and panic are common side effects. DEPRESSION, POST TRAUMATIC STRESS DISORDER, PSYCHOSIS, HALLUCINATIONS, PARANOIA, CLAUSTROPHOBIA, and SUICIDAL IDEATIONS are also frequent results. Additional studies included in the aforementioned meta-analysis further"underscored the importance of social contact for the creation and maintenance of 'self."" In other words, in the absence of interactions with others, an individual's very identity is at risk of disintegration.
