This is the type of major rule violation that DC is designed for. Well this administration gave both of these inmates a verbal reprimand. What?! Well I'm actually glad they got this. I don't like seeing DC used at all. Because solitary confinement is extremely harmful. I'm addressing this for one reason and one reason only!! As most of you know I got a minor DR on July 8th. Not only did they make sure that I serve the full 10 days on DC. I had served 7 on administrative confinement before going into their kangaroo court where they gave me 3 more days to make sure that I served that full ten. And then on top of this, they use a rule that's vague on visitation suspension, that seems to be designed for inmates who bring back tobacco products from the visiting park. But they use this to suspend my visit's, to not only harm me, but my family as well. And they say they're not retaliating. Really? Do they think everyone is stupid? You can't not recognize that this is retaliation!!! The only person who could deny that this isn't retaliation is a deaf dumb and blind fool! Verbal reprimand for a major rule violation, and visitation suspension for a minor rule violation?!! Come on this isn't retaliation over my writing? Oh course it is! Hey I can't help it that they give me all this material to write about. Your officer's are out chasing prostitutes bringing them back to a hotel room rented by the by the FDOC where he pays her with his prescription drugs. And all of this while he's there to honor the families of these fallen officer's. I couldn't make this up if I wanted to! You would think the FDOC wouldn't even want the appearance of impropriety. Well they don't have an appearance here. No they've got a blatantly obvious case of reprisal!! They let the DR chairman respond to my grievance on issues that's against him!! Now you've got to be the stupidest person on this planet to say that I, a death row inmate in solitary confinement can maintain control of that laundry bag sitting here in a cage. And these people want to know why I write about them all the time. Because their stupidity is overwhelming!!! I pray for these people to have a grain of commonsense!! Much less a grain of compassion. No they give my mother some lame excuse that a blind man can see through. God have mercy!! And this is why I'm always battling for change. This is why they refuse to work with us. Oh well.
