King(who is NOW a female) WHITE RACISM IN RICO Conspiracy. Wrongful, Unconstitutional conviction. Another atypical 1950 Mississippi type Legal Lynching. By enslavement of another Innocent Noble, Proud Black Man, Mr. Otis Lee Rodgers, Sr.,; a true, loyal American, an American Patriot, a Sixties Vietnam-era Veteran, a Sixties " Black Panther ", a Human Rights and Civil Rights Activist and Advocate: WHO STOOD FOUR SQUARES AGAINST JIM CROW FOR DECADES

Plainly put: this is an <sup>VICTIM</sup> atypical 1950 Mississippi style KKKKamgaroo, Farce and Sham trial, the trial boycotting in protest, pretrial(two-years prior to trial) in open court under oath, sworn testimony by the drafted listed, named-victim, Mrs. Joyce Rodgers, REPUDIATING the vicious, vile LIES of the lying white femi-Nazi prosecutor KKK-DDA Deborah Ann Lucky's LIES of her VICTIMIZATION; denying that she had either been Abused or Threatened by the Drafted, Listed named-defendant, her beloved husband, Mr. Otis lee Rodgers.

In a free country like Russia or China that would have been the end of this Legal lynching; No victim, No Crime, 14<sup>th</sup> Amendment U. S. C.; not so in white racist Riverside county, white savages, beast, desperate for black slave dollars and for court business to kill, enslave innocent, Noble black men

Trials without a real, Bono Fide Legitimate victim. Rodgers was tried by a white prosecutor, convicted by a white jury and condemned to 16-years of slavery by a white judge. Endured 14-years of torturous, brutal slavery at the hands of CRCR-KKK; for criminal offenses that never even happened according to the named victim, Mrs. Rodgers; SO who did Rodgers endure fourteen years of slavery

for??? Mrs. Rodgers on her hands and knees begging for forgiveness; "I DIDN'T DO IT, IT WAS THE DIRTY, FILTHY, LYING MADDOG WHITE MAN WHO KILLED YOU. Rip IN Martyrdom, the Right Honorable, Elder, Mr. Otis L. Rodgers.

RACIAL GENOCIDE, A BLACK FAMILY of 7 destroyed; five beautiful black children in diapers stripped of a father to raise and support them; Joyce, a young mother(23), husband stolen, left to struggle in poverty to raise their children alone.

QUESTION: Who did Mr Rodgers endure 14-years of slavery for? The scumbag, lying white man? WHERE IS THE VICTIM? THERE IS ONLY SILENCE.

CONSTITUTIONAL QUESTIONS:

1) Whether trial Judge Hanks had Providential or "Subject-Matter" jurisdiction to preside over Rodgers' criminal trial in the absents of a judicial determination of a "Live-Controversy" between the listed named victim, Mrs. Rodgers presented to the jury and the listed named-defendant, Mr. Rodgers? A). And in the absents of any forensic evidence indicating that a crime of injury or abuse had been committed against Mrs. Rodgers?

2) Whether trial Judge Hanks in Rico Conspiracy with prosecutor King did unlawfully and unconstitutional extort by threat of deportation and lying promise of a federal U-Visa, for perjured testimony a PERCIPIENT witness an illegal alien, Sandra Rodriquez and her two tiny, 6 & 9 year old abused, crying anchor children as percipient witness cosigners; FORCED TO PLAY THE PART OF an unheard of, unprecedented "SURROGATE-VICTIM, complaining witness at trial?

3) Whether trial judge Hank can lawfully and constitutionally preside over a criminal trial in the absents of a 'real' Bono Fide Legitimate victim?

4). Whether, when the named victim, boycotts the trial in protest, does that not strip the white man of his jurisdiction to legally lynch and innocent black man?

When will dirty white people grow up in California; the concept of crime and punishment encompasses a legitimate victim, someone who is at least willing to come to court, lie and commit perjury ~~white~~. In 18-years NO white man has had the guts or balls to end address <sup>THIS ISSUE</sup> ~~of~~ ~~trial~~ without a victim? We all know whites are racist COWARD, whose only claim to fame is lynching/killing black men.

## CALIFORNIA CRIMINAL TRIAL OF A BLACKMAN WITHOUT A VICTIM
