RGCI CAPTAINS USED THREATS TO CIRCUMVENT INMATES PREA COMPLAINTS

On February 12, 2022 Captain McCrory tried his intimidating tactics on me, spoke to me in a thunderous voice, calling me a child spouting because " I don't get my way" pretty much threatened me with everything else and of especially moving me off the housing unit, (the captain knows well that this kind of threat makes a prisoner anxious), because I said to him that I wanted to file a PREA COMPLAINT AGAINST Sgt. Anderson WHO DID A BODY SEARCH ON ME, AND INAPPROPRIATELY TOUCHED ME! Another captain, Captain Hoch did the same identical intimidation on another inmate, inmate Finch. Finch tried to file a PREA Complaint, Captain Hoch called Finch to MOS, "he was screaming at the top of his lungs: 'you better not file a PREA complaint on my staff'", said Finch. Finch told me after this encounter with Hoch, he was afraid. Finch also said that RGCI security did not take him seriously. Finch reasserted that he had to try to file a PREA complaint twice before he was spoken to, and his aggressor knew that Finch file a PREA complaint, because they went and told him, and He continued to harass Finch. A PREA complaint is supposed to be confidential, according to the federal statutes.

The supervisors at RGCI do not like to process PREA (Prison Rape Elimination Act) Complaints, they will do anything, including threats to obstruct this Federal process, simply because they have a shortage on staff. While the WDOC prints on paper that it has Zero Tolerance For Sexual Assaults. Here at RGCI the treatment is quite different! Officers like Anderson continues their predatory behaviors because they know the supervision staff at RGCI is nonexistent, and complaints like mine are swept under the rug. But I refused to be intimidated! Why did the Congress allowed DOCS, let alone, DAI (Division of Adult Institution) to conduct their own PREA investigations? Their ICRS (Inmate Complaints Review System) is inefficient, and ineffective.

It was a good Saturday, February 12, 2022, so I thought when I woke up. We had Bible study in the morning, and really some good issues were raised, especially how hard it is to be a Christian in prison. I felt good. I've cleaned my cell, took a shower, and gathered my dirty clothes to wash them. While I was doing my chores, the shift changed and Sgt. Anderson took over as our unit officer for second shift. I decided to take out the garbage out from my room. I carried the clear see-through canteen bag down the steps, at the bottom of step stood Sgt. Anderson or Henderson; he asked for me to get into position to search me, which means I have to stand in front of him (Sgt. Anderson or Henderson), while he stood behind me to conduct the body search, he had me to extend my arms, I must mention that I had the garbage bag in my right arm and my five inch diameter fan in my left hand, which I brought down to clean!

As my arms were raised and extended, Anderson frisked my shoulders and chest, he continued to frisk the rest of my body, he made the ring motion around my waist, he proceeded and I felt his hands on my buttock, mostly the top of my buttock, he the finished the body search by

touching my legs and calves. He is not allowed to touch any parts of my buttock-- top or bottom. I was surprised by what Sgt. Anderson did, I said that you just touched my butt? Anderson said "I did a search!"

he also gave me that smirk that meant "Yeah I did it!" I knew Anderson was behaving like a predator. He escalated the situation by going to search my room, later. That room search was payback for telling him that he touched me inappropriately. Anderson took my HSU prescribed Hydrophor ointment for my dry skin, he also took a lemonade Kool-aid that I intended to drink, to chase my meal that I was cooking in the microwave, while I cooking something to eat, Anderson went to search my cell, I had to wait, considering that we have to eat in the cell.

These actions are those of a correction officer who's knows that he will not be held accountable. Anderson did that to injure me. Searching somebody's cell in prison is equivalent to the SWAT Team raiding a drug house. It causes anxiety, and it causes displacement, as if one becomes homeless. All your personal property are tossed around like a room in an unruly kindergarten school. And your clothes are piled up, the clean and filth, sometimes, your personal clothes are purposefully mixed with

your cellmate's! Although Anderson did not leave my cell that way. The anxiety that he was in there, and him taking my ointment for the skin, and my drink was a warning that "I could put you in a state of anxiety", after Captain McCrory's attempt to obstruct the federal law; McCrory called me in his office where he resumed his tirade of vitriols about me,

"you don't like to follow rules Maxy", said McCrory, as he pulled my file.

I said "I thought you called me here to file a complaint!" He continued jeremiads about why I was wrong. McCrory appear to file the Complaint on the computer. Captain McCrory also refused to cite the footage of the search by Anderson as evidence to the inappropriate touching, stating that "It's not showing... anything, I just checked it", I retorted that I want the footage of the search, and the footage of the exchange between he and I, where he (Captain McCrory threatened me in the unit) to be evidence to the Complaint. McCrory kept saying "there's nothing there Maxy!" Until, I finally said that I am exhausted and I really don't want to have this conversation, and "May I leave now?" And he let me leave, and I rushed out of there, cause I felt like I was detained, when I did not do anything wrong, except the request to file a PREA Complaint! he put his hand on the taser gun on his waist, an action to further intimidate me. I don't trust the process for a PREA Complaint here at RGCI, that's why I write this article, in case something happens to me, so the world could know! In addition, today, I spoke to Ms. Grenier who is supposed to be the Supervisor who handles all the complaints about PREA in RGCI (Redgranite Correctional Institution), Ms. Grenier told me that my complaint was "not a PREA because of the nature of it..." I am going to give her the benefit of a doubt. I am assuming that it was Captain McCrory who wrote it that way; be aware that I told Ms. Grenier that if she does not file the complaint as a PREA complaint as a PREA, that I am going to notify the FBI, and anyone who is responsible for preventing the obstruction of a federal process, such as PREA! This is also obstruction of justice, and everybody involved is conspiring to obstruct the same. Let me add that today we had a visit from some young lady who claimed to be the "PREA representative" for the State of Wisconsin. She the "PREA representative" also echoed Ms. Grenier, she also said they tried to handle my kind of situation "in a different solution", I asked her "How?"; she did not have an answer for me! She left as if she was a wounded animal. If she was assaulted at her job, or in any other setting, I know she would call the "ME TOO

MOVEMENT!" But, she was standing there defending this type of conduct by Officer Anderson! I can't believe she even let that thought cross her mind

I am writing this article for the express purpose of alerting the public, this is also my preemptive path to keep the administration at RGCI honest. Because, honesty is not their forte, they are unable to tell the truth, but they think they are better than people like myself! If you don't get another post concerning this issue, please contact the FBI on my behalf. I do not trust the RGCI administration with my life.
