You can come in scared and remorseful and nobody will give a damn and after a while you wont either . Prisons are not filled with dangerous, vicious criminals, the likes of Susan Smith or Jeffrey Dahmer. By most conservative estimates, seventy-percent of all prisoners have been incarcerated for non-violent offenses and should be released. It is indisputable as to whether that dangerous criminals belong behind bars and even that small percentage needs to be treated humanely. While they may be unfit to remain in society, they most certainly are not unfit to remain in the human race and to be treated humanely; after all there isn't anyone alive who hasn't committed an error or even a crime; obvious some more heinous than others. When dealing with another what is just and fair cannot be determined by the frenzied fears of the public or an angry mob; inflamed by the prostituting voting getting politicians ameri-KKK has over two point three million captives(prisoners) being held in concentration camps, 25 percent of all the world's prisoner and ameri-KKKa is only five percent of the world's population'and I'd posed that same question to all prisoners' what should be done with career criminals, a sort of brainstorming. Taxpayers pay billions of dollars each year to lazy criminals with badges to wage war on crime; and even the nonsensical "War on Drugs", who wages a war on an inanimate object; and the taxpayer's pilfered tax money hasn't shown a profitable return as in the reduction of crime. It seems the more laws are enforced, the more crime increases. According to crime watchers, crime is steadily increasing. No private company in the world would tolerate or operate in the red for decades and decades I would incorporate the Vermont Plan of Reparation for all non-violent offenders, utilizing a Reparation Board into the Parole Board system. How it would work is that a prisoner would apply to the Community Reparation Board for release under their supervision and that of a parole officer.

I'd also declare the offender I'd also declare amnesty for one year, allowing any offender to turn themselves in, confess, admitting to his or her offense and be guaranteed the minimum punishment or less; and/or possible entry into the Community Reparation Program. I would decriminalize all illicit, so-called street drugs, providing drug distribution centers; rehab outlets with programming for an admitted confirmed addict. Consensual moral and vice crimes would also be decriminalized, albeit restricted to sections of town historically referred to as "Red Light Districts".. WHY PRISONERS SUE?

There are those who question "Why this epidemic of unprecedented lawsuits by prisoners against their keepers? **THE ANSWER IS VERY SIMPLE** Zero accountability and a lack of any other Due Process alternatives to resolve a prisoner's complaints. From my observation, abuse, mistreatment during my 29 year tenure of cross-country and intermittent interment, prisons and jails are maintained and operated at a zero accountability to prisoners and the general public. Prisoners have no rights that most prisoner guards are willing to accept or respect. In truth how could it be otherwise? These people-keepers are the lowest of the lowest, the scum of the earth: to hold another human being against his will under threat of death if he tries to escape while serving him dog food AND SOYBEAN FILLER; in subhuman environment environment; deprived of physical intimacy with his loved ones; grossly inadequate medical care and means of supporting himself; deprived of all other bare minimum amenities afforded a human being ~~XXXXXXXXXXXX~~, standards now afforded a human being in our evolving civilized society, which distinguishes humans from animals.

The government jaded idiotic propaganda is that prisoners sue for any nonsensical, frivolous (e.g., soup served cold, not enough recreational activities, mail was a few minutes late, etc.). **WRONG!** I am sure that the aforementioned may have happened from time to time; but as most of "us" alert individuals are aware; government officials routinely and regularly LIE, to the very people that they have sworn to serve. Lying to the uniformed, misinformed, apathic taxpayers is the norm. Again, if you think about it, how could criminals with badges do otherwise? Bottom line, prison guards are in prison for the same reason as prisoner, they couldn't/didn't make it on the outside. Prison guards/officials aren't paid to think or trained in the humane treatment of others. From my experience most are unstable, neurotic, dysfunctional individuals without a conscience or moral, ethics and willing to do anything and whatever their supervisor orders them to do; no different than the Nazis.

Imagine if fate dealt you the misfortune to be held captive by this racist, satanic regime and you were in need of life saving medical treatment? And the slave-masters response was that cosmetic surgery, we don't do that. Bearing in mind that neither your fatal illness nor your suffering is cosmetic. Imagine if you were routinely being denied fundamental human decency such as privacy and basic needs. What would you do? Yeah, I know you'd complained and complain upon dead ears of an indifferent prison officials to assist in maintaining the integrity of your humanity and/or to save your life. Then and only then as a last resort and at great personal sacrifice(intimidation and retaliation) and expense to yourself you'd sue and sue and sue.
