LET THE RECORD REFLECT AND BE DOCUMENTED FOR ALL TIMES ESPECIALLY THE RECORDED HISTORY OF THE (U.B.A.) UNITED BLACK AMERICA. TO KNOW OF MY MERITORIOUS, FACTUALLY BASED CHARGES AGAINST THIS WHITE REGIME(CALIFORNIA) OF DOMESTIC WAR CRIMES - HUMAN RIGHTS VIOLATIONS ; RACIAL GENOCIDAL ATROCITIES COMMITTED AGAINST ME BY WHITE PROSECUTOR/JUDIARY(RIVERSIDE COUNTY, CALIFORNIA 03') IN RICO CONSPIRACY(HEREAFTER THE KLAN). HAVE STOOPED THIS LOW.THE TRIAL BOYCOTTING IN FEAR OF KLAN REPRISAL NAMED VICTIM HAVING FLED THE STATE TESTIFIED IN OPEN COURT TWO YEARS PRIOR TO TRIAL UNDER OATH. A). But because my skin is black and under that state's racist defacto JIM CROW laws - a Blackman is not allowed to have the victim at trial to expose the white prosecutor's lies.

2). Also as punishment for violation of an ancient(1998) technical parole terms, that wasn't thought about until 15-years after the fact. And was complied with a dozen times
