At no time did I ever intend any of the above as measures of manipulation to help gain an early release. But my enculturating college classes on the other hand — are intended to qualify for an easier reintegration if and when ever I'm given another opportunity to function as a contributing member of society in the future. I only began college when I learned early parole was a real possibility in 2017.

Never did I think there would be a future with loved ones and friends I left behind 25+ years ago. Yet 2023 opened communication lines with a couple who've reminded me — who I was... isn't who I am. Hopefully someday they'll realize that.
