

I am still being subjected to an intense institutional bias. Here at Jefferson City Correctional Center as ~~an~~ nonending means of retaliation(s) for the lawsuit I filed against them the first time I was at this prison (i.e. Irving v. Dormire, 519 F.3d 441 (8th Cir. 2008) (Guards made death threats and took actions to carry death threats out)). Please note: the present assistant warden \*Raina Martin was a defendant in this lawsuit and maliciously has previously tried to block me from being transferred to continue violating my U.S. Constitutional Rights and circumventing to try to have me assaulted / stabbed here. On \*3/20/23 at around 3:50 am in the morning CO3 Lt. Davison; CO2 Sgt. Thompson and another Sgt. subjected me to a violent cell-search leaving my cell violently disheveled; stealing a bundle of my poetry writings; postage stamps; and destroying several photos of my family members. I then had me punished with alternative meals illegally. I have been upon \*suicide watch since 3/21/23 and just removed today due to threats made upon my life by CO3 Lt. Davison and

CO2 Sgt. Nicole Ellzey, I am posting this because: Your advocacy and help is needed still please! I am in danger here housed at Jefferson City Correctional Center and need to be transferred immediately. They have Dr. Smith falsifying papers against me to unethically take my medical bottom bunk and bottom walk lay-ins given to me by doctors at other prisons. "I need your support please call: Ms. Melissa Massman; Mo. Dept. of Corrections, (573) 751-2389 (or Director Ms. Anne Presythe); [REDACTED] MO. State Representative, Ms. Kimberly Ann Collins, (573) 751-1400; Mr. Mike Kehoe, Lt. Governor, (573) 751-4727; The Mae Arthur Justice Center, (314) 234-8540; and Ms. Brianna Peril, J.W.O.C., (816) 866-3803 and lodge verbal complaints in my behalf please that you all want me transferred from Jefferson City Correctional Center to another level 5 prison in Missouri to cease retaliations; institutional bias and malicious violations of my U.S. Constitutional rights and continuing measures to have me harmed. Also, it is asked that CO3 Lt. Davison; CO2 Sgt. Thompson; CO2 Sgt. Ellzey; and Dr. Smith be

disciplined with 2-weeks off without pay and directed to stay away from me until transferred. "I'm so mentally anguished from being constantly unconstitutionally circumvented against - I don't want to write or post too much more poetry while here!..." I have been held in ad-seq 1-year - when I could have been transferred to another prison in Missouri and released to General Population with no problems. Your help is needed - Thank you greatly!
