

The devastation of tragedy due to negligence
that keep happening at Pulaski State Prison

Sunday the 28th of August, 2023 around
approximately around 8pm I notice red spot
was all over my body. I was having an allergic
reaction to something. I had no way of getting
to medical staff, no officers that came to
the dorm E2. Even though we are on of quarantine
dorm. Currently we are on a 10 day quarantine
because someone tested positive for covid-19.
Even though we are quarantine dorm. When there
are medical or mental health emergency. We should
still be allowed to go get help.

So Sunday night all night I suffered this allergic
reaction. ~~each~~ itching by the time I got up my face
was swollen it had spread worst all over my
body. When I finally saw a officer come to the
door to bring the breakfast. It was one of the
sub-officer from another prison. He said he
will tell medical. No call to medical etc.

Then another sub came, she got on the radio
in call medical a numerous of time. ^{Monday 29th August,} ²⁰²³ They
never came. So Nurse Young came, I showed
her. She said she would get somebody to
bring some Benadrials because she had to
go to F1 etc. to do they pill call. you would

to help me. They removed all the sub-officers some where else in the prison. Because they didn't want them to help us in no form or fashion. All this happen early morning of Monday approximately 10am on the 29th of August 2023. So medical never came. When our morning shift officer came (Mrs. Hobbs) I showed her how my body was messed up with Hives and my face was swollen. Do you think she picked up the phone and call medical. She left me at the estate I was. So I suffer more. I told the pill call nurse yawn what was going with me. She said she would get somebody to bring some Benadrals because she had to go to Fl etc to do their pill call. You would think someone would have taken me to medical immediately - the way I was looking - somebody would be concerned, absolutely not. Did I get the Benadrals quickly, absolutely not. The allergic reaction was festering rapidly since it had been in operation all night and half of day. For some reason officer Jones came into the building. I said could you please call medical because this allergic reaction is taking over my body My face was swollen and I had hives

The medical finally came, ~~with~~ two nurses
in brought me the two Benadrals. Before
they gave me the Benadrals. They ask
me what was I allergic of. I told them
everything. Then they gave me the ~~Benadral~~
Benadral. That was about 3:00 pm.

~~I know know~~ knocked on the window
asking another inmate from another dorm
to tell officer Hobbs I needed medical ASAP
because my lips had swollen and allergic
reaction was even worst. She never came
to E-2 and she ignore my problem. Then when
she came, she said the nurse is coming for
pill call, you need to tell her. Nurse Jansen
said to officer Hobbs could she get to medical.
The officer (Mrs. Hobbs) said yes. When the
nurse scene me in the infirmary. She asked
our doctor could she administer a
~~Benadral~~ Benadral and steroid shot. So she
gave these two shots. As I was walking
out of medical I became real dizzy, faintish
and nausea. I ask the Deputy Warden
Northcut of security could I please go
lay on the chairs in medical until I can
feel a little better. She was real nasty to
me no. I ask a inmate could she bring
me some water. I was laid out on the pavement

by security. Deputy Warden Marcut left me on that pavement laid out. Didn't try to get me no wheel chair or nothing. After I laid on the pavement and drunk the water. I said maybe I can make it to the fencest one - thru 5. But when I get around the corner three inmates setting at the gate. Of course I could not go to the gate because I was from^a quarantine dorm. ~~I then said to the~~ I asked the inmates at the fence, where is officer Hobbs. She said she is not coming to open the gate until she gets off from work. Remember I was dizzy, faintish and nausea. The inmates was telling Deputy Warden of security, she said she is sick. She is lying on the pavement in front of the library. The inmate kept saying you are not going to help her. I said she don't give a damn about us. Once again no wheel chair. When officer Hobbs finally open the gate, I had to walk fast because everything was spinning around, I was almost to pass out. I got to the pic-nic table. I said officer Hobbs could you please tell someone to come help me. I kept saying I am about to pass out and I feel sick to my stomach. All officer Hobbs said you made it this far. You can make it in the dorm. Happen

Jessica Alamina and my cousin Wynda Bell
help me to my room on my bed. I kept
saying I feel dizzy, faintish and nauseous.
Once they got me on my bed I threw up
everywhere on the floor and the trash can.
After laying down for a few minutes I
was able to take a shower and go to
sleep. But when I woke, my skin is still
messed up. Today August 29th 2023.

Around ~~11~~ 11 pm, ~~the~~ Sgt. Bright was
in the dorm with some nurses from outside
of the prison that was doing our covid-19
test. I said Mr. Bright I am having another
allergic reaction on my leg. I need medical
again. Do you think he picked up the phone
to call medical instead he said he will
go and tell them. Come to find out when Nurse
Munoz and another nurse was outside the dorm.
I showed her my leg that I was having a
allergic reaction. She said Sgt. Bright didn't
tell them anything. I kept ~~push~~ push are you'll
gang to help me. Nurse Munoz said I will
them when I get back to medical. Then she
began to get this nasty attitude storm back outside
the door as if I was being a nuisance. The other
nurse said she should have gave you a steroid
shot yesterday. I said Ma'am she gave me
a steroid and Benadral shot yesterday I could tell

by Nurse Munds attitude I was not going to get help. When she came in the building, she made all the inmates get on their hall for pill call. So I squeeze by going to Deputy Warden of Administration telling him about my situation. He said give her a chance to do what she said she was going to do. I knew ~~the~~ Nurse Munds was going to help me, because one I am not a boyish girl. Another inmate in the dorm stole their Benadral they got at pill call for me. So that is how I got a Benadral for the ~~the~~ Allergic reaction. Yesterday when I finally got to medical my throat was closing up. The Allergic reaction was so bad, I was so sick at Washington State Prison. I kept going to medical saying I was sick. All they treated me for indigestion. I end up ICU for 10 days and my family never knew. I had my mother in-law called out here to get me medical help. They gave her around for her money. She was flashed over to medical in they took the phone off the hook it went busy. The person in main control, got smart their medical operate 24 hours a day. If that be the case why can't I get help with my

medical condition. The other day I had a sick call. Because I am on quarantine I am not allowed to go to my medical appointment. That is not true. I cannot be denied medical under no condition. Here it is August 30, 2023 I woke up this morning swollen all over in Hives another allergic reaction. Since we had it seen a officer all morning. I got on their phone in call ~~to~~ the officer said is this a inmate I said yes sir I am having allergic reaction and I am swollen. My name is Jennifer Johnson could you please send medical to help me, please. He slammed the phone down in my face. A few ~~minutes~~ minutes later Sgt. Richardson was on E-1-E-5. I told her, look I am having allergic reaction could you please tell Sgt. Richardson to call medical. I looked at the inmates telling her about me. She kept walking and locked the gate. I stopped in talk to another officer and ignored my medical condition. At 9:30 am the nurse has not even brought the dorm their pill call. As if they trying to avoid even taking care of my condition. Sgt. Richardson came back through the gate at 9:33 am but still has not come to the dorm or called medical. Now bubble are under my skin. My whole body is red and I am itching real bad. Due to ~~the~~

Munos got in attitude yesterday because I was expressing I needed help because I had new allergic reaction. I cannot take none of medicines. Cause I am scared of everything now. Barely eating. I have real bad chronic asthma. When the nurse finally took me to medical the other day my throat was closing up. This ~~morning~~ morning my throat ~~is~~ sore. Nobody is helping me it's scary. Negligence on purpose. After time people here of inmates dying but nobody never get the truth from the inmates behind the walls. Tragedy #1 Pharina Peterson. Mrs. Peterson arm and hand was swollen so big. Everyday for a whole month many of us met her on the walk saying they want help me. She said Deputy ^{Care and Treatment} Warden Mahogany keeps kicking me out of medical. By the time they get her to the hospital the fluid had spreaded over ~~her~~ her body. She had heart problems. Negligence on purpose. Let her died. I talk to Nurse Cottels the pill call nurse at 10:05 she to headed back to medical. She said she is going to talk to Nurse Beck because she said I need to be seen at medical ASAP. I told her about my throat hurting, I showed her the allergic reaction. I told her it's all over my body. I told her I haven't been able to

eat like I am suppose to because I am scared. I also let her know I haven't been able to take my asthma pumps and medicine because I am scared. This allergic reaction is dangerous to me because I have chronic asthma which is dangerous. Sgt. Richardson came to the building at 10:12 ~~pm~~ am do you think she acknowledge my medical issue absolutely not. Suppose medical didn't do nothing. Yes the Captain was in the building 10:14 nurse Cortels came back to get me, she met Captain Roberts and Sgt. Richardson on the walk. She was pointing at the building she needed to get me. Mind you the Captain (Roberts) was taking inmate Ustach to Dialysis in medical. I give This inmate is in the same quarantine dorm E-2. These people turn my help around. Now here come Sgt. Richardson again 10:22 Am. I am going to see if she escort me to medical. Absolutely no - went straight to E-1. So I am sitting here swollen up, itching with hives all over my body and throat hurting. Purposely negligence on Sgt. Richardson and Captain Roberts behalf. Now Sgt. Richardson still have not come to get me - gone to E-3 and Captain gone back to his office in security setting. While I sit here in suffer. Nobody suppose to deny no inmate medical help regardless of

10:35 am my lip begin to swell. Captain Roberts came in with the Cafeteria Supervisor Mrs. Carter. I met him in the Sally port crying. Showing him my lip had swollen up. He kept saying medical got to do something. In order to get to medical I had to stress my personal medical issue in the presence of other inmates. He was still treating my medical condition as nothing. I had to say Captain Roberts I have chronic asthma and I can die from this allergic reaction because if my throat close up - He said well it sound like you breathing to me. I said captain Robert the other day my throat begin to close up and today my throat is sore. Finally after he has humiliated me for a little while he got on the phone and called medical they send me on. This all in the name quarantine. At this point I feel in humane. I was crying going up the walls. I placed in the treatment room Nurse Shirley, Nurse Beck and Nurse Mann took of me they went above and beyond to help my medical condition. Two nurse walk by looking at me shaking their heads. Because they are friends with officer childs, officer Harper and officer Anderson they don't too much care for me because they are friends with these officers. Nurse Munas, Nurse Yawn and Nurse Danci - These particular officers cannot stand me because all they

do is gossip. So these nurses treat me as I am not here to give you what you want. When it's not about I want something it's about my health - to take care of it. I am not to be here to be no staff friend. This whole clique is very personal with certain inmates. So to the point they call them mom and Auntie etc. When any staff make me feel inhumane cause I ~~sick~~ am sick and feel like I am trying to get my way. That is one sick individual they need some type of help. Especially when you let your own person's vendetta come between my medical issue because this officer said this about Jennifer Johnson. I am no longer going to suffer because somebody lazy, or play politics with certain inmates. I am not the one for this. Today I am exposing everything. They let Monica Cutts die deliberately. That was purposeful negligence. When they brought her to our cell 150 at 12pm at night, she had cut herself. Why didn't she get to the safe cell. While she was in the cell she was constantly pleading for help for her because she was hearing voices. She even wrote Doctor Little, consulted Kilgore, deputy Warden of Security Northcutt, even the mental health nurse in medical. They said she was just acting. Then she went around saying the black box was saying people was going to rape her. People got scared begin to run from her. @ me and the other bunkie slept on the

Hallway floor because she was constantly stand over bunkmate at night. Everybody we reported everything to ~~the~~ thought she was acting. So we was on quarantine then they wouldn't take this girl to the suicide watch. So the Warden Moesha McMillian, ~~and Deputy Warden~~ Deputy Warden Butts, Northcutt and Deputy Warden of Care/Treatment came in for inspection everybody raise their hand about the issue. They remove Monica Cutts, we thought they put her in suicide watch instead they put her in a two man cell gave her fun. She hung her self. In lock down they normal take all your electronic in put them in that closet. Straight negligence. That Sunday she tried to get us out the room because she wanted to commit suicide. We would ^{not} leave the room, when we realize what she was ~~do~~ trying to do, we kept our room door so we could let everyone on the hallway see what was going on. I feel its important to let her family know she loved her children. They was her proud and joy that all she talked about her children. There is something else that was triggering her mental reaction. She had this penpal that was visiting her. She would come back crying from that visitation room crying everytime. I said Monica if this man is emotionally abusing

you need to stop going to visitation room because we don't like seeing you like this. I truly believe the investigator need to go back in find this dude on her visitation list. in hold him accountable because shortly before Moniza being taking out for locked ^{down}. She said he went to another state. She didn't know where he was. This accident with those kids really affected her tremendously we had to go get her out of the shower naked on the floor, constantly crying I didn't ~~mean~~ mean to do it I am sorry, I am sorry - guilt was eating her up from her crime. How we view inmates, how we treat their crimes, how we treat medical and mental health issue matters behind bars. Nobody should be treated inhumane because you think the inmate want their way or because their are a personal vendetta against a inmate because of their crime or just because the inmate don't want to be part of the fanclub with staff. Significant others needs to be monitored more closely who they let behind these visitation walls. Another inmate ~~set~~ and her husband set Monica Cutts with this man. Pharina Peterson and Monica Cutts don't have a voice no more its was taking because of the constantly negligence at Pulaski State Prison. Deputy Warden Butts, Warden Maesta McMillian is gone but everyone ~~is~~

else in this essay needs to be demoted and release
to work at another facility. When it come to medical
and mental I don't play because no one should
make you feel inhumane about ~~your~~ the inmate
condition. Once ~~to~~ again Today I will not keep
my mouth closed. Nobody is going to continue to
mistreat us at Pulaski State Prison. Regardless why
we in prison our medical and mental health
condition is important.
