Warden Ms. Heather Cooper or Mr. Tim Freeman), pro se as an indigent prisoner w/ no outside support who is in good-hearted seek of advocacy from kind-hearted individuals in relation to immediately remedy a conspiratorial violation of his U.S. Constitutional Rights per malicious / vindictive False Report per Conduct Violation *ERDCC 23-08986 cdv # 3.1 Falsified by *CO II. Sgt. Makala Drope *EO 156324 in conjunction w/ Secretary *Ms. Green and E.R.D.C.C. Maintenance. (Please Note: An impartial and detached (from E.R.D.C.C. employees) endepth / intense investigation will very likely reveal a *Criminal Code of Silence Ring act, operating and under intense criminal circumvent- ion w/ prison gang members active- involved in selling *sex; bringing contrabands (clothes; watches; iphones; tobacco; k-2; Pentnyl; meth. etc.) and covering up criminal conducts / U.S. Constitutional Rights violations by staff and the gang members etc.)

Sorting them. An intense lengthy investigation of these E.P.D.C. employees (and staff will unearth criminal/unconstitutional conducts from falsifying cdv.'s against prisoners to ~~having~~ sex and bringing synthetic drugs and drugs; ~~COII~~, Sgt. Makala Drope; ~~COIV~~, Captain Ms. Neal; ~~AAA~~ Gang Task Force Officer ~~COI~~, Ms. Halton; ~~AA~~ Secretary (H.U.#4) Ms. Green (also known as Bilford); ~~AA~~ Food Service Women Employee Ms. Madison; etc.; H.U.#10 & #11 MO. D.O.T. employees/prisoners working work release; COI, Ms. Barton; COI, Ms. Urper; COI, Ms. Smith (prisoner workers from H.U.#4 porter (Chi rag) to Captain Ms. Neal's prisoner porter (Juvy) to H.U.#1 - c-wing walkmen (C-Man); to almost all food service workers (Galli, etc.) are selling synthetic drugs B2 or drugs!

I was released from Administrative Segregation H.U.#1 - c wing on Nov. 9, 2023 per a cdv. #3.1 written on July 12, 2023 in which I owned responsibility as knife belonging to me. I was in General Population H.U.#4 - a-wing cell #103 for a total (11) eleven days where which the toilet stool line had become clogged up at least (5) five times and

both me and my cell mate Anthony Erby #1035588 had to get the plunger from staff. On Nov. 20, 2023 after breakfast the toilet became clogged again and we requested the plunger from COI. Mr. Countryman and asked Mr. Countryman to put a work order in for maintenance to fix our toilet stool (i.e. clean out the line). As we were going to lunch H.U.#4 Secretary MS. Green (Billford) was observed exiting the Control Bubble (where here; COI. Ms. Halton; COII. Sgt. Makala Drope; COI. Ms. Barton; COI. (Ms. Morrison) are known to sit in and allow prisoners of H.U.#4 to masturbate to them minus cdv. #7.3's (violating Missouri State Law RSMo. 566.145 and MO. Dept. of Corrections' policy). It is known that Secretary MS. Green is frequently planting dangerous contrabands in cells and stool lines and she had on a pair of blue rubber gloves. I point out that I'd just a few days previously written (2) two complaints to supervisor COIV. Captain Ms. Neal and administrator MS. Heather Coffey on MS. Green (Billford); COII. Sgt. Drope; COI. Ms. Halton watching prisoners jack-off and allowing H.U.#4 prisoners to break the MO. Dept. of Correction rules (i.e. out

- of bounds (in other wings; cells; Housing Units) doing drugs; selling drugs; fighting; stealing; stabbing (etc.). After we came back from lunch COT. Sgt. Drope said Maintenance got a knife 6^{3/4} inches out of rear toilet line and asked was it mine in which I truthfully responded "No!", I take responsibility for knives if they are mine and why would we ask for a *Work Order if either me or my cellmate had put knife in stool?.. (It's totally illogical.

Please Note: This knife was not mine or cellmate and was likely planted by Secretary Ms. Green (Bill Porter) working w/ COT. Sgt. Makala Drope (who is rumored to be selling sex to prisoners and women men employees). Green; Drope and Halton had been soliciting me for erotic photo I would not provide. Warden; (573) 358-5536 and lodge a verbal complaint in my behalf and ask for in depth investigation into criminal/unconstitutional conducts of staff here w/ prisoners; incl-

uding bringing drugs; having sex; watch-
ing prisoners masturbate; planting knives
and falsifying conduct violations
as a means of retaliation. (Note:
No room inspections of cells or toilets
are being done which could evidence
knife already lodged in toilet by pre-
vious occupants before I moved in
cell #11 eleven days previously, and
you would like Gov. #3.1 Dangerous
Contraband dismissed and expunged
and me immediately removed from the
Administrative Segregation Housing
Unit #2 back to General Population w/
all rights/privileges restored; dir-
ective issued to H.U.#4 staff; Classifi-
cation and Supervisors to cease retat-
iations) and that Secretary Ms. Green (Bill-
ford); Ms. Hutton; Drope and violator's
staff be reassigned from H.U.#4 to no
contact w/ prisoners; disciplined
w/ 2 weeks off w/out pay and consider-
ed for termination/prosecution of
employment along w/ other violative
E.H.D.C. employees (including Captain)
(& Food Service Workers) and that
the need transfer of *Stretch Gang
prisoners in H.U.#4 be split up per trans-
fer immediately please. Your help is needed
and appreciated greatly! THANK YOU!"
