All of certain when it comes ~~down~~ down my \$1800 Stimulus I have been getting a total run around for it because they sent me this account number to bank ~~stating the bank~~ called Old national bank. Then I kept getting hassled around about this money. Given 10 days everytime I have written them. I have been at the same address they sent my \$1400 at. I even sent them a proof of incarceration showing I have been incarcerated 26 years. They still holding me accountable for whoever has scammed them out of my \$1800. I have never had a bank account I have been locked up every since I have been 23 years old. At this point I feel the IRS should give me my \$1800.00 dollars. Nobody should be held accountable for someone else action.

Second problems is our families are being scammed on many levels. in State of Georgia (Corrections department) who they have connected themselves to do business with. We can order a food and clothing package through

My mother in law sent my package (food) same as she always do through a postal money with a ~~tracking~~ tracing fee. Everyone had gotten their package in my dorm except me and a couple other inmates. For myself it was strange for me who gets this package everytime the prison give us the form I send it home to my mother in law who has a total of four people to get packages for that are incarcerated. She is on a fix income as well as my father in law. This the third time I have had a problem like this. The other two times they sent my package late. Now this has come down to them taking money, lying and send checks to other addresses. Months ago I had heard of inmates ~~calling~~ pretending like they are the person family member on canceling the inmate order having the money re-routed to a person of interest address in getting the money. Sending it to the inmates. My ^{mother in law} mother has yet to get her money back from my package last time. Now she has just order another food package. Also Union has a problem with getting all the orders filled. My mother in law got my uncle in law money order back ~~for~~ saying she didn't put the order in time. The other day one friends mother order a \$95.00 clothing package. Her money was taking. The same mom put \$90.00 on the phone. A additional \$90.00 was taken by Securix. This taking our family money tripping through ~~the~~ ^{out} Georgia Department of Corrections. AS the Georgia Department

of Correction has out inmate accounts and who send us ~~for~~ finances, public knowledge. This should not be public knowledge because other criminals access to our family names and what we have on our accounts. This how anyone can call union supply in cancel our orders rerouting the checks and taking our stimulus etc. A lot of scams are coming out of the prison.

This is a humongous problem as well securus is charging our families a 3.95 process fee ~~for~~ ^{to put} minutes on the phone. At the prison we can put up to \$200 on the phone but everytime we talk on the phone its .14 a minute. 215 and our families are being ripped off. My mother in law and father in law is on fix income. They are in their 70s. Barely can get around is that fair to them? I am in a position where somebody has to send me money. Because Georgia don't believe in paying their ~~inmates~~ inmates. Today I spoke with another inmate who had been in the South Carolina Department Correction. Their families can put money on the prison phone system without a fee. Each of their calls are .99¢. So if their family put \$10.00 they can talk for 10 times. They can buy a phone card off their commissary. Their phone calls are still 99¢ a call. This is not right how Georgia Department of Correction is doing their inmates and family.

Georgia Department Correction commissary prices are ridiculous. When we complained about this we learn that a percentage is going towards to pay the recreation ~~dep~~ and chaplain Department. Why is our money going towards paying them in the state of Georgia. When both of those departments are

Rarely used. Cause we do not have any activities in the gym ~~building~~ rarely because there is not enough staff. Are we @ rarely having any church services. If your family member die. Basically ~~you are~~ you are by yourself. Who gonna let you out the building to get the chaplain or its not promise their going to come check on you, for prejudice and bias reasons. So why are we giving them a pay check? Our families send us this money not to pay others for doing nothing. Especially all three of my children are struggling financially. My daughter is a therapist at a middle school. Her car was taken in the middle by the toll because she couldn't pay the bill. She had to catch a uber cab to work that was almost \$50.00 a day. She has to have \$1600 dollars in seven days or else she will continue to be without a car to get to work. Then her rent just went up again she stays in Atlanta, GA. My oldest son is working driving trucks but not making enough to meet ends for his family. My baby son is working for this company. But he is struggling financially, just can barely make ends meet for family. Both of their parents are in prison.

Christopher B. Morman and Jennifer D. Johnson Morman. Their parents and uncle Michael B. Johnson was sentenced to life with possibility of parole. They was convicted of murder in the death of their son Joshua N. Johnson ~~in the~~ in August 1997. Case No: 97-R-072. All their conviction was appealed in the Supreme Courts of Georgia. I don't know ~~the~~ appeal numbers. Every single piece of the evidence was unrealistic against Jennifer D. Johnson Morman and Christopher B. Morman.
