My brother Michael B Johnson put our child to bed. Actually was the last one to see him alive. We had no reason to kill Joshua we was good parents. But I have always had problems with my family being jealous of me. Especially when I prosper.

My mother Linda D. Johnson controls my brother Michael every move. This case has left our family

for decades without the people they love and  
really no answers truly behind Joshua's death.  
The parole board keep blocking the release of  
Jennifer D. Johnson Morman and Christopher  
B. Morman. They have been denied parole  
2011, 2017 and 2023. Everyone in our family  
is tired of the confusion behind this case. As  
Michael continue his terrible behavior towards  
me (the sister Jennifer D. Johnson Morman).

Who is serving a life sentence with the possibility  
of parole. Recently Michael purchase a 200,000  
dollars house in my name. Has constantly been  
purchasing all kinds of products in my name.

Everytime I try to get help nobody wants to  
listen to me. As well Christopher B. Morman  
and Jennifer D. Johnson Morman is still being  
persecuted in the City of Bainbridge by her  
brother Michael and grandmother Linda.  
They keep blocking our parole. Which is not  
right because my mother Linda D. Johnson had  
a case with the Bainbridge Welfare Department  
in Bainbridge Georgia for child abuse against  
her daughter Jennifer D. Johnson Morman  
who spent 90 days in foster care. So how  
could she be that effective candidate to say  
my Christopher B. Morman and Jennifer  
D. Johnson Morman deserve to die in prison  
etc. The same for my brother Michael B. Johnson  
who was present at our apartment everyday,  
Eating our food and play acting like he was  
for us. If their was child abuse going on  
why didn't he or anyone report it before  
our son Joshua death? I would have if  
I seen a child or anyone getting hurt.

Another problem I have is why does the judges and district attorneys has a say so in our parole continuously? When there's no credibility amongst their people who was on the case.

The investigation surrounding ~~our~~ our son Joshua's death was very shady and far fetch. There was a document that surface at the begin of the case where GBI Michael Walsingham told Doctor Anthony Clark to say our son Joshua was bleeding out of the mouth and diaper but Mr. Clark came back in said that is not true. My husband Christopher B. Mormon was arrested first. They let him out on bond. Then came back in arrested Christopher B. Mormon, myself Jennifer D. Johnson Mormon and my brother Michael B. Johnson. How is your going to arrest my husband Christopher B. Mormon on the same charges. That doesn't make sense to me. To make things worst the cause me and my husband to lose everything jobs, apartment and custody of our children. GBI Michael Walsingham went our jobs and to the landlord talking about we wanted for murder. When was out on bail, this was totally ridiculous to me on the State of Georgia behalf in this case. Why would anyone go out of their way to lie, especially if you took a oath. Who does this, I would say a person who really don't have a case.

GBI Michael Walsingham was following us everywhere including to church. Clearly there was a plot to put us away even if it included setting traps. I did self incriminated myself out of fear because they said I wouldn't never see my other children. They questioned me

So long not caring I found my child in the crib not breathing. Nobody cared how that affected me. GBI Michael Walsingham took that video had the State witness to go over the self incriminated video before trial. People was telling me all the things Lexis going on behind the scene. Every move the investigator was making. People who had my best interest and was sadden by the way the case was being handled. They would say to me this is not right. Why are they going out of their way to trap you all?

A couple of weeks before trial a friend of someone in the family let them know that GBI Michael Walsingham had been by the house trying to get a friend of my husband to tell something on my husband Christopher B. Mormon. The very next me and my husband Christopher B. Mormon was setting in the car out by his aunt house. Just talking about what life has brought us. All of sudden a light of a vehicle was driving fast into the side of ~~my~~ the car where I was a passenger. My husband Christopher crunched the car real quick driving fast towards the city limit of Donelsonville GA. Hoping to loose the vehicle. As turning on the main highway. I seen the vehicle it was a green hunter type jeep. I was like why are they so after us. When we didn't do nothing. That very night me, my husband and my unborn could have died right there. Because where we was considered the country a lot of wooded area. If we would have died their would

haven't been no witnesses. Everything came to light of who it was when my husband called his friend to take him to job interview. He left with them. My husband Christopher don't stay gone long away from me unless he is at work. In my guts, I felt something was wrong. We get a call from Colquitt jail my husband Christopher had been arrested for aggravated assault and simple robbery. We immediately went to the jail guess what I see when we get to the jail. The same green hunter jeep that tried to run into our car was present. Guess who was on this case GBI Michael Walsingham - same person on our murder case. We couldn't shake this dude (he was white) and we are African American. Remember this same GBI went to Chris's friend's house wanting him to make something upon him. Week before this robbery Chris had gotten out of the same friend's car because he tried to my husband still gas from the convenience store. The only reason he got him to take him to the job interview he was desperate to get a job so he could support his family. Mind you my husband was not on bond. Nobody should not be harassed into a conviction. The other co-defendant his friend and other boy didn't really get nothing out the robbery which I think it was another set up by GBI Michael Walsingham. The victims in the robbery wanted to drop the charges on Christopher my husband. Did not show up for court. GBI Michael Walsingham told the victims

My husband was wanted for murder. When that was a lie because he was out on bail. But GBI Michael Walsingham made sure the State picked up the charges.

Then on another occasion when my husband Chris was walking and this boy he knew attacked him. The boy's mother took a warrant out on my husband Christopher for aggravated assault until she discovered her son grabbed my husband first. The mother of the boy went in dropped the charges apologizing. Once again GBI Michael Walsingham tried to have the State of Georgia pick up the charges on my husband Christopher. Why is this man so after my husband Christopher, clearly it's racially motivated. Cause he said my husband was a drug dealer because he had a Starter Jersey.

During the whole case it was flawed under the leadership of GBI Michael Walsingham. We were totally harassed. If I asked my public defender for something such as another expert witness on the case. My attorney ignored me, then later on telling me the State expert witness knew what he was talking about when it came to our son Joshua's death. On my appeal my lawyer only had two grounds on her appeal. Neither defendant was allowed a appeal attorney. Instead they trial attorneys handle their appeals. Which was unfair to have them on their ~~appeal~~ appeal.

Our son Joshua's death was a time for the State of Georgia to rationalize its own

to create situations that was unreasonable in order to convict two good people who deserved a fair trial and fairness in the Supreme Court of Law, which led me to think the State had something to hide in our case. They did when it came to my child foot burning after one of their State witness had kept our children while I went to the post office. later on finding out their State witness was on crack. The judge kept this out the court room. In the trial transcript the judge told the district attorney. We're not going get into this mess about the footburning. Keep this mess out of the court room. Never identifying who killed Joshua. In the courtroom the district attorney address us as such one of them at table killed that baby. Lee & was round up like a bunch of hogs. Because ~~we~~ we are African Americans. Which was obvious as they continue to harass through the parole board and create situation that seen to be so real.

But all the while their GBI Michael ~~Walsingham~~ Walsingham was willing to do anything in this case to get rid of Jennifer D. Johnson Morman and Christopher B. Morman ~~who~~ who pose a threat in the community. Which is false but the real threat was the narrative they create surrounding our name and our son's Joshua's death. I believe our story needs to be covered and who is this GBI Michael Walsingham, Linda P. Johnson and Michael B. Johnson trying to keep us locked up. Why was GBI Michael Walsingham very determine to put Christopher B. Morman ~~and~~ behind

bars because he thought he was a drug dealer. When he wasn't, many smoke marijuana but don't mean they're a drug dealer. This whole theory came about when my husband Christopher B. Norman went to my mother Linda D. Johnson house asking why she put my brother Michael out the house. She called the police under false pretense that my husband was a drug dealer. When my husband was a hard worker that was dedicated to Elberta Creek factory in Bainbridge, GA. Had no reason to drug deal. ~~Second~~, Why was the State of Georgia worrying about Christopher and my marriage? We don't understand what this had to do with our son's death. My husband loved all our children even though he was not their biological father. The investigator made a big deal ~~of~~ if because he wasn't the father. My grandmother raised five children that was not her biological children, when she met my granddad he already had five children. Grandma loved as if each child were her child gave birth to. My husband was the same way with my children. Not all stepparents are evil. Another thing my husband loves me with a everlasting love and still does. I feel like this case was orchestrated by my mother's family jealousy and racially driven by the State of Georgia criminal justice system in Bainbridge, GA.

Today this issue needs to be over because our children and grandchildren needs us. This sentence need to end for us being in the Georgia Department of Corrections. Because of the Corruption with the judges, district attorneys in Bainbridge intertwining with my brother Michael B. Johnson our co-defendant, Monica Johnson, Johnny L. Johnson Jr and Linda D. Johnson. This whole

Case was pathetic and didn't make no sense surrounding our convictions and our ~~sister~~ Joshua's death. We are tired of the disappointments with the Georgia Parole Board everytime we come up for parole, according to the people up above and on the parole board we haven't done enough time. Which makes me wonder is Michael B. Johnson guilty but he is trying to blame it on us. The question is why is every after us. Especially our co-defendant ~~to~~ Michael B. Johnson who we provided a roof over his head freely as well fed him. ~~for~~

I hope our story is worthy to cover and helps us.
