greatly appreciative!" Unfortunately!, I am being
subjected to retaliations (direct and 2nd party 1st
amend. violations) in the form of mail obstruction
(1st amend. viol.) of incoming personal mail (by Housing
Unit #2 guards: COT. Sgt. Padora; Sgt. Smith; Sgt. Lee; CPT:
S Berget; Rose; Clark; Malaken (in circumvention of
*COT. Sgt. Makala Drope) and legal mail (by F.U.M. Mr. Boy-
er; Heather Gross; and Lisa Hooker); denial of equal
protection of the law (by COT.'s: Kaylie Spanhook; Pro-
vince; Wich; Blue; etc.). I am also being denied med-
ical treatment (8th amend. viol.) by medical per nurses
Kaylie; etc. refusing me to see Dr. Irving for migra-
ine medicine renewal; KOP medication for high
blood pressure and needed *eyeglasses are being
denied to me here at E.B.D.C. as a mean of sub-
jection to *Unconstitutional Civil Conspiracy bec-
ause I refuse to give into civil extortion
tactics and allow medical and staff to have
my poetry writings and erotic prose for free. I
print out: "I have chronic high blood pressure and
am beginning to have frequent reoccurring chest
pains I have blacked-out in cell twice and the
Administrative Segregation Housing Unit #2 guards

under supervision of F.U.M. Mr. Boyer and COTT.
Lt. Brett Renk and COTT. Sgt. Recker are not
answering * Emergency Call Buttons and nurses are
refusing me Emergency Self-Declare treatment
and I am on the verge of a stroke or heart
attack (**life-threatening) and I also being mal-
iciously blocked from adequate access to the
courts per caseworker Mrs. Lisa Hooker refus-
ing to obtain my legal documents/materials
from E.B.D.C.C. Property Room. Unsafe Conditions
(8th amend. viol.) at facility reside here w/ a myriad
of employees deeply engaged in criminal and
unconstitutional conducts w/ high ranking
supervisors prompting it and assisting w/ cov-
er-up. An investigation into COTT. Sgt. Makala
Drope (* selling sex to prisoners (and personal relat-
ionships) and to staff) and Ms. Green (also known
as Ms. Billford) (* planting knives; bringing K-2; con-
traband) need to be administered impartially
