

DEAR friends, comrades & advocates!, clad in solidarity: PLEASE!, assist me in this struggle here at E.R.D.C.C. that has me kept in the center as the focal point of an *unconstitutional conspiracy w/ staff of guards (some); nurses (unable to get medical care/pre-scribed meds) and one nurse illegal tampering w/ my liquid-preserved medications (no sick call done/ no doctor seen/no dental) will not provide needed eyeglasses here in the Administer (allow Segregation Housing Unit #2); and classification staff caseworker (Mr. Jones) subjecting me to an *unimpartial tribunal; and classification Committee of F.U.M. Mr. Terence Anderson; caseworker Mr. Edmund Jennings; and Ms. Sarah Cook yet to place me in for the needed transfer to above these *unconstitutional and gravely unconstitutional conditions I am presently bound to.

I am unable to go into greater detail about what is going on here for fear my outgoing mails will be unconstitutional censored again

by Deputy Warden Ms. Heather Coper. My incoming mails are maliciously trashed and over censored by COII. Sgt. Dahmm; COII. Sgt. Bergger; COI. C. Taylor; COI. Walters; COI. Wycoff; COI. Foster. My 1st, 8th and 14th Amendment Rights are flagrantly being violated.

I am an indigent prisoner, w/o no outside assistance or support from family or friends, who is wrongfully convicted of the crime of which I have been convicted, in hopes one of the Innocence Projects will decide to accept my case and represent me to be exonerated.

"I cannot tell you if my sister (Chanel M. Irving) and my niece (Chakay Givens) are still alive— mysteriously in 2012 all communication between us stopped (nobody will tell if anything tragic has happen—and I fear the (2)

worse). One of my daughters' mothers was killed around 2007. In 2021 my cousin was murdered by officers in Kansas City, MO.; one of my aunts died of a heart attack—then, my half brother (Don't Brown) whom just found me and began e-mailing—committed suicide. To compound troubles upon the heart, the day I was transferred to E.R.D.C.C. May 30, 2023 I was told by a prisoner my father (Leon Gunn) died at another prison in Missouri.

I come to you all goodhearted and in need, "I have been beaten for meals by malicious/jelous guards and supervisors; I've had a Priority mail outgoing box of legal documents (to Innocence Project) stolen and trashed by a Sol.; I can't get medical care; dental treatment; nor broken eyeglasses replaced here (because I won't give all my poetry to nurses); I am in filthy unsanitary condition and presently housed in wing w/ enemies under danger." Yet, I post my poetry (heart, soul & mind upon page) unsaf.

ishly to you all since 2008. "Where there is smoke!, there is fire (or was).

PLEASE!, get behind me w/ verbal complaints per calls to request I be transferred from E.R.D.C.C. to another level 5 prison in Missouri and the unconstitutional conducts described herein against me be immediately remedied and violative staff disciplined. A Hunger Strike is declared today May 24, 2024 at dinner meal (nurse tampering w/ my meds name is Kala (first)).
