All three of my children had to fight everyday at school. One of the students that was bullying my older son, planted a pocket knife in his bookbag at school. Which led my child to go to the juvenile ~~detention~~ Center.

My children reported incidents to the teachers. Many teachers came up against my children and started to mistreat them as a nobody. Because they know their parents was locked up in prison. One teacher went far as to tell my daughter that she will never finish ~~school~~ and never be nothing in life. All my children are grown but they remember every single encounter they had to endure at the hand of a bully. I share this to let you know we have to start viewing this topic from many angles. But some views has been neglected, so this is why America keeps having mass school shootings. The truth be told, many people prays on people who are quiet. Because they think you up to something. They can't figure out what

your thinking. So that put your enemies at odds with you. All three of my children are quiet. I am a quiet person. ~~If~~ If you're that type of person, what is the ~~best~~ best way to get that person upset. One is to poke at them with a rumor about a parent or ~~themselves~~ themselves.

We have to be careful how we ~~evaluate~~ evaluate situations' in life. We don't know the threats and mental health impact Colt Gray went through as result of the deceased students' and teachers'. Mental Health is everything to our family, So much so till that same daughter works for a suicide line for 12 hours. My daughter and I had a conversation about Colt Gray. As my daughter was saying the whole situation was said "It sad momma, they could have helped him. The whole world failed this little boy." Then she said, everytime I hear the story "I cry." My daughter and I have a heart for children. "My daughter and I, has the same purpose in life to save ~~the~~ children from destruction.

We're all know a Colt Gray. They may not have shot up the school. But they are walking around everyday in the same shoes crying out for help. The same as Colt Gray was asking for help as he let someone know that he was being bullied. If no one helped him, he was going to take matters into his own hands at the age of 13 years old. Not one single person handle the situation in a reasonable manner. ~~The~~ The dad, school counselor, the agent that says he was on the radar, DFACS, and the School failed this little boy. Even the mom warned the school. How ~~sad~~ Sad nobody did anything to prevent this devastation.

On the hand, why is this becoming ~~normal~~ normally where parents are putting guns in the hand of children? It is sad to know Colt's dad purchase a high power AR-15 for christmas. I will have a automatic red alert button that signal to my mental health staff where the problem is and the child's post will pop up so they can read it. Immediately going to the school or the house of the child to help them.

My professional blog business will be a prevention to keep children off the road of destruction. My goal is to take down the percentage rate to school shootings, dropouts, violence in the streets and homes, as well as incarceration and suicide. Finally reducing the mental health ~~tragedies~~ tragedies that we hear about everyday. Truly ~~I~~ I desire to be that solution to our youth problems.
