"THE MORE YOU KNOW"

The Florida Department of Corrections always puts family first. They believe in building up the family structure where the prisoner has strong family ties. Now if you believe that, you'll believe anything! That's the lie they sell the public. But actions speak louder than hollow words. And as I'll demonstrate here, the FDOC's actions shows that their about dividing family and friends from the prisoner. For instance they've slowed down the e mail communication throughout the FDOC to where you can no longer carry on a conversation. The email communication five years ago was much faster. You would receive emails within hours, whereas now its taking days and sometimes weeks. You would think with technology it would have sped up not slowed down.

Here in P-dorm where I'm housed, we were getting the phone once a week on a scheduled night. Understand if they cared about family contact, they could place the phone on each wing every day allowing unlimited phone calls to our loved ones. Instead what they have done, is put out a memo stating phone calls will no longer be allowed, once a week at night. They stated because we have day rooms, we have access to the phone during day room hours, not accounting for families being at work during our day room hours. Like I said, action's speak loud and clear.

Why stop there, prisoners who have drug addictions aren't given treatment for their addiction. That's a fact! I was trying to help someone I know get treatment a few years back. Our classification officer had no idea how to even approach this. She sent emails to the chaplain and others only to run into a brick wall. You know what the FDOC's answer is? Suspend visitation for a year! Cut the prisoner off from family and friends. No contact visits, no video visits, absolutely no contact. Yes they place him in a solitary confinement cell to struggle alone with his addiction. How is that helping anyone? How is that strengthening the family unit? Well its not. Its tearing the family unit apart. Which is what the FDOC wants to do.

If your still questioning what I'm telling you, then I encourage you to go Google and read Prisoners on Prisons Vol.4 No.2 (1993)The article is by Eddie Griffin, "Breaking Men's Minds: Its about Behavior Control and Human Experimentation at the Federal Prison in Marion using Dr. Edgar H. Schein's full technique of Brainwashing. Its a technique in his book entitled Man against Man, for which he presented to the Bureau of Prisons at the 1962 conference in Washington D.C. And its a techniques still being used to this day. One of the techniques taught is," UNDERMINING OF ALL EMOTIONAL SUPPORT." A second technique is, "PREVENTING CONTACT WITH ANYONE NON SYMPATHETIC TO THE METHOD OF TREATMENT AND REGIMEN OF THE CAPTIVE POPULACE." Yes this is the truth, and what the FDOC is actually doing with limiting us access to the phone, and cutting off family contact with a year visitation suspension. This isn't something they want you to know, but its something you need to know. So I encourage you to look at the methods their using. They are trying their best to frustrate you to where you as a family member or friend will cut ties with that prisoner and have the out of sight, out of mind mentality. What they sell the public, and what they actually do is as different as night and day. Divide and conquer is their overall goal. Slowing the emails down, cut down

on phone calls, cutting off visitation, making visiting registration more difficult, limiting visiting days for families traveling hundreds of miles restriction restriction. Does that sound like their supporting the family unit? And their response is, security. To that I call bull sh**! Phone calls are recorded, emails are documented and my family and I will actually talk about what's in the emails before they arrive. And the drugs, don't get me started. They knowingly let that come back here. The Florida National Guardsmen who have been assigned back here for the past two years, recognized what's going on. So throwing up security is as lame as them saying they support this family unit for the prisoner. And that's a fact! When it comes to the FDOC, always keep in mind, that its an unethical immoral agency that is as corrupt as it comes. Do your homework.
