I had responded to your post
and questions before previously—
but, I don't believe it made it through
due to staff here stealing mail. That
being, and you are such a poetry-
lover and my biggest (and maybe only)
advocate.— I had to ensure that
you get my response(s), and!, I wrote
some poetry posts just for you and
the haikus you love!

But first to answer your ques-
tions: 1) Presently, yes I am out of Ad-
Sec, and I had got transferred from the
other prison I was at when you sent
this post. I got to this prison B.E.C.L. on
November 12, 2025;

2) As far as the status of my case, presently!, I do not have any motions or petitions filed with the Courts. To elaborate on my situation so you will have as clear as an understanding as I am able to paint—I have no outside support from friends or family. I am in the process of trying to construct a pro se Rule 91 State Habeas Corpus Petition to try to file (minus an attorney) in state court in Missouri. I have been avid with tirelessly shopping my Actual Innocence Account to attorneys; organizations; etc. — lawyers don't want to help you if you don't any money. As a result of shopping my Actual Innocence Account — in 2018 the Midwest Innocence Project began (and still is —) reviewing my case files — but, has yet to sign on to represent me. I've sent them boxes of legal documents. Understand a conflict of Interest may exist in which is may be the cause I am getting black-balled from being represented: "My trial counsel Laura O'Sullivan previously around 2013 did some work for (and may still be doing —) the Midwest

Innocence Project and is at the head of my claims (i.e. failure to investigate eyewitnesses; and alibi witnesses; and launched an unethical investigation of her client into other cases, etc.). In addition, the Innocence Project in New York, N.Y. also began reviewing my case files extensively in 2020 ~~but~~, no one from their organization has signed on to represent me yet either. I am going through the stages of their process — but, it has been 8 and 6 years respectively. And in 2024 I filled out questionnaire to be reviewed by the Exoneration Project in Chicago, IL. It is so so severely difficult without outside support/assistance and internet access. Plus, these prison staff do to hinder and obstruct a person way trying to reobtain their liberty or bring court actions against them, especially when they possess a talent or gift. I don't know why I keep posting the poetry? ... It's been up since 2008. I have to have like enough poems for 5 books there... only maybe 8 or 9 people respond beyond

the typical "Favorite." You are appreciated!,
for being an eccentric — unafraid to
elaborate and take the time to appreciate
me; and the poem — "you love the way
lovers love, keep loving and apprecia-
ting Art and the Artist both!.. For
Lovers like you; and to Resee Liberty
is the reason I fight and write (not
necessiably in that order.)

"My bestest to you and your
family most kind and binding!.."

them. I need all the help God will send
to assist me. Bless you! Check my posts,
these are for you.
